STATE OF NEW JERSEY JUVENILE JUSTICE COMMISSION 2022 PREA ANNUAL REPORT

The New Jersey Juvenile Justice Commission (JJC) submits the following report to satisfy its obligations under the Prison Rape Elimination Act (PREA) for incidents occurring during calendar year 2022.

Summary of Findings

The JJC continues its efforts to implement best practices and promote zero tolerance for sexual victimization of its residents. Significant education related to PREA has led to a higher awareness by JJC residents and staff, leading to greater reporting and accountability.

In 2022, the average daily population of residents within the JJC was 186, and over the course of the calendar year, the JJC served 324 youth. During 2022, there were 18 allegations of sexual abuse reported, resulting in a rate of 5.55 allegations per 100 youth. The JJC investigated each alleged incident reported in 2022 in accordance with U.S. Department of Justice PREA Standards, 28 C.F.R. 115.371, and applicable New Jersey laws and rules. Of those investigations, eighteen (18) were determined to be unfounded, none were unsubstantiated, and none were substantiated.

In comparison, in 2021 the JJC served 328 youth during the calendar year and reported 35 alleged incidents of abuse, resulting in a rate of 10.67 allegations per 100 youth. Thirty-four (34) of these cases were determined to be unfounded, none were unsubstantiated, and one was substantiated.

2022 Findings¹

• In 2022, 18 instances of alleged sexual abuse were reported and documented.

An unsubstantiated allegation is an allegation that was investigated, and the investigation produced insufficient evidence to make a final determination as to whether or not the event occurred.

A substantiated allegation is an allegation that was investigated, and sufficient evidence was put forth to support finding that the abuse occurred.

¹ An unfounded allegation is an allegation that was investigated and determined not to have occurred.

Federal Reporting

The information contained here is also reflected in the JJC's Survey of Sexual Victimization which the agency completes each year for the Bureau of Justice Statistics within the U.S. Department of Justice.

Ongoing System Review

The JJC publishes this annual report regarding PREA-related incidents and continues to improve the agency's prevention, detection, and response efforts on an ongoing basis, regularly conducting sexual abuse incident reviews to determine if changes to or improvements in environmental, procedural, staffing, and/or monitoring technology are appropriate. Over the past two years, a number of JJC facilities have made physical plant changes that have improved privacy for youth and increased surveillance capabilities. This includes, for example, installing shower partitions to provide privacy and upgrading and/or installing cameras to enhance supervision. The JJC will continue to request capital budget funds to support ongoing efforts to ensure state-of-the-art camera systems exist throughout JJC facilities.
