Under supervision of a Supervising Investigator or other supervisory official in the Division of Consumer Affairs, Bureau of Securities, conducts in-depth regulatory and administrative audits and inspections of licensed premises; reviews records, files, financial statements, and other transactions to determine compliance with rules or regulations governing State securities laws; conducts, under guidance of a team leader, civil and regulatory investigative activities or investigations, requiring specialized credentials, to detect alleged noncompliance with or violations of the New Jersey Uniform Securities Laws, administrative codes, or Professional Rules of Conduct; provides investigative information and assists in the drafting of administrative orders, administrative complaints, no-action and interpretive releases, and performs analysis of the New Jersey Uniform Securities Laws; will perform other related duties as required.

REQUIREMENTS

EDUCATION: Graduation from an accredited college with a Bachelor's Degree.

EXPERIENCE: Three (3) years of experience in the conduct of civil or criminal investigations related to compliance, enforcement, detection, and surveillance activity, including the preparation of investigative reports; **OR** three (3) years of experience in the conduct of investigative administrative audits and/or regulatory examinations of records maintained by businesses and organizations; **OR** three (3) years of experience in the conduct of investigations for the government, the military, consumer protection programs, public advocacy organizations, or the public interest.

Applicants who do not possess the required education may substitute experience as indicated on a year-for-year basis.

Completion of a supervised internship field placement of 300 hours in an undergraduate curriculum in Criminal Justice or a related degree program may be substituted for one (1) year of the non-supervisory experience. *A copy of your transcript indicating completion of the internship as part of your undergraduate degree program must be provided in order to meet this substitution requirement. Failure to do so may result in disqualification.*

A Juris Doctorate degree or a Master's Degree in Criminal Justice, Public Administration, Business Administration, or other related field may be substituted for one (1) year of the indicated experience.

LICENSE: Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is required to perform the essential duties of the position.

PREFERENCE: Preference will be given to candidates with a Juris Doctorate degree and/or candidates with experience in a compliance role at a financial institution, bank, broker-dealer, insurance company, and/or investment adviser; or at a law firm representing financial institutions, banks, broker-dealers, insurance companies, and/or investment advisers.

RESUME NOTE: Eligibility determinations will be based upon information presented in resume only. Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide an evaluation indicating the U.S. equivalency prior to the closing date.
