<u>DUTIES:</u> Under the supervision of the Director or the Deputy Director, Victims of Crime Compensation Office plans, organizes, supervises and manages the Investigative Unit to ensure compliance with governing statutes, rules and regulations; creates quality assurance and quality control protocols for the claims process; monitors and develops procedures to ensure optimum unit/individual performance; supervises staff and work activities; prepares and signs official performance evaluations for subordinate staff; responds to inquiries from the Office of the Attorney General and other government offices related to victims' claims; performs other related duties as required.

REQUIREMENTS

EDUCATION: Graduation from an accredited college or university with a Bachelor's degree.

EXPERIENCE: Six (6) years of office and/or field experience conducting investigations, collecting evidence and preparing investigative reports related to criminal, civil or regulatory matters involving fraud, misrepresentation or other acts of criminal or civil misconduct. Three (3) years shall have included supervisory responsibility.

<u>NOTE</u>: Experience as a police officer performing criminal follow-up investigations (not preliminary investigations) may be substituted for the above non-supervisory experience on a year for year basis.

NOTE: Applicants who do not possess the required education may substitute experience as indicated on a year for year basis.

NOTE: A Master degree in Public Administration, Business Administration, Social Work, or Criminal Justice may be substituted for one (1) year of experience.

PREFERENCE: Preference will be given to candidates who meet the above requirements and have victim services experience.
