**DUTIES:** Under general supervision of a State Investigator 1 or other superior officer in the Division of Gaming Enforcement, Department of Law and Public Safety, conducts complex investigations and assesses compliance with the relevant aspects of the Casino Control Act, primarily Section 99, Sports Wagering Law p.l. 2018, c. 33 as well as the attendant regulations associated with casinos and racetrack Sportsbooks in New Jersey. Evaluates and investigates casino and sportsbook operations including, but not limited to, cashier transactions, table game and slot accounting operations, count room operations, and accounting and internal controls. Assists in the training of new investigators.

#### **REQUIREMENTS**

**EDUCATION:** Graduation from an accredited college or university with a Bachelor's degree.

**EXPERIENCE:** Four (4) years of experience in planning, organizing, and coordinating activities of an organization or agency engaged in large-scale investigative activities, one (1) year shall have been in a supervisory capacity and shall have included the review and analysis of financial and accounting records.

**NOTE:** Applicants who do not possess the required education may substitute additional experience as indicated on a year-for-year basis with thirty (30) semester hour credits being equal to one (1) year of experience.

**NOTE:** A Master's degree or certification as a Certified Public Accountant may be substituted for one (1) year of the indicated experience.

**LICENSE:** Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.
