<u>**DUTIES:**</u> Under the direction of a Human Resources Manager, as a trainee and productive worker, assists with the preparation and processing of various personnel actions including, but not limited to recruitment, payroll functions, benefits, ECATs, and maintenance of personnel files. Does other related work.

REQUIREMENTS

EDUCATION: Graduation from an accredited college or university with a Bachelor's degree. Applicants must submit a copy of your final unofficial transcripts, which indicates the date your degree was conferred and the type of degree awarded. Failure to submit final unofficial transcripts with your resume will result in disqualification from consideration. Applicants with foreign degrees must submit an evaluation with a course-by-course breakdown. Matriculating students cannot be considered.

LICENSE: Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.

ADVANCEMENT: Appointees who successfully complete the 12-month training period will be eligible for advancement to the title: Personnel Assistant 4 in accordance with Civil Service Commission procedures. The inability of an employee in a trainee title to attain a level of performance warranting advancement shall be considered cause for separation.

RESUME NOTE: Eligibility determinations will be based only upon proof of degree and information presented in resume. Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide an evaluation indicating the U.S. equivalency, with a course-by-course credit listing, prior to the closing date. Failure to do so will result in your ineligibility.
