**DUTIES:** Under the limited supervision of senior staff, drafts proposals and adoptions for new rules and rule amendments; functions independently on routine issues and assists with complex regulatory matters, including the analysis of federal regulations and their preemption of NJRC rules. Prepares all required paperwork and obtains all necessary approvals prior to filing proposals and adoptions with the Office of Administrative Law. In connection with senior staff, acts as a liaison with the Division of Law for contested cases, appeals and litigation. Performs other duties as assigned which may include research, drafting orders and final decisions, writing memoranda, reviewing applications, and serving as back-up records custodian.

### **REQUIREMENTS**

**EDUCATION:** Graduation from an accredited law school with a Juris Doctor (J.D.) Degree. Appointee must be eligible to practice as an Attorney-At-Law in the State of New Jersey.

**EXPERIENCE:** Two (2) years of experience in conducting legal research, analyzing and evaluating legal documents, rules, regulations, and/or legislation, or the review and analysis of regulatory matters in a government agency; or two (2) years of experience as an attorney, one (1) of which must have been in conducting legal research, analyzing and evaluating legal documents, rules, regulations, and/or legislation, or the review and analysis of regulatory matters in a government agency.

**PREFERENCE:** Preference will be given to candidates who have experience in regulating horse racing.

### **LICENSE:**

Appointee must possess a current Certificate of Good Standing issued by the New Jersey Board of Bar Examiners, or other license to practice law issued by any state in the United States.

Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.
