**DUTIES:** Under limited supervision of a supervisory official within the Information Technology Section, Division of Administration, Department of Law and Public Safety, is responsible for logical data modeling, analysis, design, development, and implementation of Data Modeling, Data Integration, or Data Warehousing solutions using Data Management technologies; may administer technologies related to Data Modeling, Data Integration, and Data Warehousing; may coordinate Data Modeling, Data Integration, and Data Warehousing projects; may work independently on data modeling projects; does other related duties as required. This position may also require non-traditional work hours, on an as needed basis, including evenings and weekends on short deadlines for certain assignments, with or without advance notice, and may require travel to perform the aforementioned responsibilities.

### **REQUIREMENTS**

**EDUCATION:** Graduation from an accredited college or university with a Bachelor's degree.

**EXPERIENCE:** Three (3) years of experience in systems analysis and design, data modeling, and/or data warehousing solutions delivery, one (1) year of which shall have been primarily in logical data modeling.

**NOTE:** A Master's degree in Computer Science or Computer/Information Technology may be substituted for one (1) year of systems analysis and design, data modeling, and/or data warehousing solutions delivery experience.

**NOTE:** A Bachelor's degree in Computer or Computer/Information Technology plus a Master's degree in Computer Science or Computer/Information Technology may be substituted for two (2) years of systems analysis and design, data modeling, and/or data warehousing solutions delivery experience.

**SPECIAL NOTE:** An Associate's Degree in Computer Science or Computer/Information Technology and two (2) additional years of experience in systems analysis and design, data modeling, and/or data warehousing solutions delivery may be substituted for the required Bachelor's degree.

**LICENSE:** Appointee will be required to possess a driver's license valid in New Jersey.
