<u>DUTIES</u>: Under general supervision of a supervisory official in the Division of Consumer Affairs, Administration Section, Department of Law and Public Safety, supervises staff assigned to the payments section and evaluates performance; supervises the daily processing of payment vouchers, OPAY documents, U1s, UAs, transfers and other transactions involving changes to account balances; ensures the adequacy and effectiveness of the payments and transfer processes; supervises and oversees travel, trip approval and associated reimbursement transaction; reviews and ensures the accuracy of analysis done to ensure adequate funds are available to facilitate bill payments and other account impacting transactions; participates in enhancement of fiscal system process and in implementation of fiscal systems; performs other related duties as required.

REQUIREMENTS

EDUCATION: Graduation from an accredited college or university with a Bachelor's Degree.

EXPERIENCE: Four (4) years of experience involving the review, analysis, and evaluation of budget, organization, administrative practices, operational methods, management operations, or data processing applications, or any combination thereof, which shall have included responsibility for the recommendation, planning, and/or implementation of improvements in a business or government agency.

NOTE: Applicants who do not possess the required education may substitute additional experience as indicated on a year-for-year basis with thirty (30) semester hour credits being equal to one (1) year of experience.

<u>NOTE</u>: A Master's degree in Public Administration, Business Administration, Economics, Finance, or Accounting may be substituted for one (1) year of indicated experience.

<u>LICENSE</u>: Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.
