**DUTIES:** Under the direction of the Director of the Office of Law Enforcement Professional Standards, assists with the administrative activities necessary for the efficient functioning of the Office, including the supervision of the other units within the Office; works on policy and guidance and regulatory matters, including those relating to State Police and law enforcement practices; interprets and enforces laws, regulations, policies, procedures, and codes of conduct; prepares formal reports and makes recommendations; oversees investigations; law enforcement training; and works collaboratively with State Police and other law enforcement agencies; does other related work as required.

### **REQUIREMENTS**

**EDUCATION:** Graduation from an accredited law school with a Juris Doctor. Admission to practice as an Attorney at Law in the State of New Jersey is required.

**EXPERIENCE:** Four (4) years of experience as a practicing attorney, one (1) year of which shall have been in a supervisory capacity.

**LICENSE:** Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform essential duties of the position.

Appointees will be required to be compliant with all Executive Orders (EO), mandates, policies, and directives related to Covid-19, including testing and vaccinations, and including but not limited to EO 252 (Murphy), EO 283 (Murphy) and/or EO 290 (Murphy).
