The Environmental Enforcement & Environmental Justice Section (EEEJ) provides representation to the Department of Environmental Protection and other State agencies and commissions in Federal and State court and administrative litigation to enforce a wide range of Federal and State environmental laws. The Clean Air Unit of the section is dedicated to the enforcement of the Federal Clean Air Act, including enforcement actions brought in concert with other states and the federal government against coal-fired plants in New Jersey and other states. This section was recently moved to the Affirmative Civil Enforcement Practice Group to enhance its efforts in the areas of Cost Recovery and Natural Resource Damages cases as well as other federal-facing and multi-State litigation.

DUTIES: The Assistant Section Chief works under the supervision of the Assistant Attorneys General in the ACE-T Practice Group, and the Section Chief of the EEEJ Section, to provide counsel and representation to the Section's clients; assists with planning and managing the supervision and operations of the Section; assigns matters and supervise Deputy Attorneys General in the Section; litigates and supervises litigation, as needed; evaluates the performance of assigned Deputy Attorneys General; conducts case file reviews; and performs other duties as required.

REQUIREMENTS

EDUCATION: Graduation from an accredited law school with a Juris Doctor. Admission to practice as an Attorney-at-Law in the State of New Jersey is required.

EXPERIENCE: Four (4) years of experience as a practicing attorney, one (1) year of which shall have been in a supervisory capacity.

LICENSE: Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.

RESUME NOTE: Eligibility determinations will be based upon information presented in resume only. Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide an evaluation indicating the U.S. equivalency prior to the closing date. Failure to do so will result in your ineligibility.

If qualified, applicants must complete a Division of Law attorney application for employment found at www.nj.gov/oag/dol-hiring. While completing the application you will be instructed to upload supporting documents including but not limited to: a resume, cover letter indicating interest in job vacancy announcement #22-51, a copy of your Certificate of Good Standing with the Supreme Court of New Jersey, a legal writing sample (unedited by others), a copy of your unofficial law school transcripts (self-prepared transcripts are not acceptable), and an Affirmative Action form. All items must be submitted together, in one package, via the DOL online attorney application portal, on or before the closing date of January 17, 2022.
