**<u>DUTIES:</u>** Under direction of a supervisory official in the Office of Education, Juvenile Justice Commission, assists in the design, production, and delivery of curricula, training, program improvement, and related education services to education agencies to ensure achievement of mandated goals and to meet existing and emerging needs; performs mandated regulatory functions; under supervision, performs work of a professional nature in monitoring and evaluating education programs in school districts statewide; performs other related duties as required.

## **REQUIREMENTS**

Applicants must submit proof of Master's degree completion and proof of New Jersey teacher's, supervisor's or school administrator's certificate issued by the State Board of Examiners and/or other professional endorsement Certification with resume.

**EXPERIENCE:** Three (3) years of experience in education programs in a school district or other educational institution.

**LICENSE:** Appointee will be required to possess a driver's license valid in New Jersey only.

**PREFERENCE:** Preference will be given to candidates with School Social Worker, School Psychologist, or Learning Disabilities Teacher-Consult certifications.
