## **REQUIREMENTS**

**EDUCATION:** Graduation from an accredited college with a Bachelor's degree including or supplemented by twenty-one (21) credit hours in accounting. *A copy of your transcript is required.* 

<u>NOTE</u>: A valid New Jersey Certificate as a Certified Public Accountant issued by the New Jersey State Board of Accountants may be substituted for the Bachelor's degree plus the twenty-one (21) credit hours in accounting.

**EXPERIENCE:** Three (3) years of variety of experiences involving the auditing or the installation, operation, and maintenance of large-scale accounting systems.

<u>NOTE</u>: Applicants who possess the twenty-one (21) credit hours in accounting but do not possess a Bachelor's degree may substitute additional experience as indicated on a year for year basis thirty (30) credit hours is considered equal to one (1) year of college. *A copy of your transcript is required*.

<u>NOTE</u>: A Master's degree in Public Administration, Business Administration, Economics, Finance, or Accounting may be substituted for one (1) year of experience as indicated above.

**LICENSE:** Appointee will be required to possess a driver's license valid in New Jersey.

**RESUME NOTE:** Eligibility determinations will be based upon verification of the 21 required credits in accounting and information presented in resume. Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide an evaluation indicating the U.S. equivalency, including a course-by-course evaluation, prior to the closing date. Failure to do so will result in your ineligibility.
