**DUTIES:** Under direction of the Administrator of Investigations in the Division of Gaming Enforcement, Department of Law and Public Safety, conducts and coordinates complex investigations to determine financial suitability of casino licensees and foreign and domestic affiliates and/or holding companies for the issuance and maintenance of casino licenses; evaluates complex financial transactions; conducts ongoing financial stability reviews; conducts compliance, enforcement, and related investigative activities involving application for licensure and violations of the Casino Control Act and Division of Gaming Enforcement regulations; prepares detailed and accurate investigative reports containing findings, conclusions, and recommendations; oversees the financial reporting requirements of the casino industry; projects casino-related tax revenues for the New Jersey State Budget; evaluates financial reporting requirements for internet gaming and sports wagering; performs other related duties as required.

### **REQUIREMENTS**

**EDUCATION:** Graduation from an accredited college or university with a Bachelor's degree.

**EXPERIENCE:** Five (5) years of experience in planning, organizing, and coordinating activities of a work unit engaged in the conduct of background and/or criminal type investigations, two (2) years of which shall have been in a supervisory capacity and shall have included the review and analysis of financial and accounting records.

**NOTE:** Applicants who do not possess the required education may substitute additional experience as indicated on a year-for-year basis with thirty (30) semester hour credits being equal to one (1) year of experience.

**NOTE:** A Master's degree or certification as a Certified Public Accountant may be substituted for one (1) year of the indicated experience.

**LICENSE:** Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.

**RESUME NOTE:** Eligibility determinations are based upon information presented in resume only. Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide an evaluation indicating the U.S. equivalency prior to the closing date. Failure to do so may result in your ineligibility.
