An opportunity currently exists in the unclassified service with the Department of Law and Public Safety, Division of Criminal Justice, for applicants who meet the requirements specified below:

NUMBER OF POSITIONS AVAILABLE: One (1) – Location preference required.

DUTIES: Under administrative direction of the Director of the Division of Criminal Justice, the Office of Securities Fraud and Financial Crimes Prosecutions' Legal Chief, or other supervisory officers in the Office or the Division, as well as the Attorney General, or other executive officers in the Department of Law and Public Safety (LPS), this Deputy Legal Chief will help lead OSFFCP's mission to investigate and prosecute significant securities fraud and financial crimes that undermine the fairness and integrity of our financial systems, exploit investors, and prey on vulnerable individuals across the State of New Jersey and beyond. This work involves identifying and developing investigations, evaluating legal issues, assessing evidence and potential criminal charges, and assisting in the prosecution of criminal actions. The Deputy Legal Chief will supervise teams of investigators, analysts, and deputy attorneys general, in the investigation and prosecution of criminal conduct to accomplish OSFFCP's mission. The Deputy Legal Chief of OSFFCP, working with Office and the Division executive and investigative staff, will be responsible for the cultivation, improvement, and maintenance of strong working relationships with local, state, and federal law enforcement partners, relevant community stakeholders, the AOC, as well as other LPS Divisions and State agencies. In doing so, OSFFCP's Deputy Legal Chief will effectively coordinate law enforcement efforts. The Deputy Legal Chief will represent the Office, the Division and/or Attorney General on various Supreme Court committees, councils, specialized committees, and advisory groups; will oversee taskforces and special initiatives/projects; and will perform other related tasks, as required.

REQUIREMENTS

EDUCATION: Graduation from an accredited law school with a Juris Doctor. Admission to practice as an Attorney at Law in the State of New Jersey is required.

EXPERIENCE: Four (4) years of professional legal experience as an attorney at law of the State of New Jersey in the area of the specialty or, three years of professional legal experience as an attorney for State or Federal administrative agencies which shall have involved a significant amount of the specialized legal work, or, two years of unique specialized legal experience.

LICENSE: Appointee will be required to possess a driver's license valid in New Jersey.

PREFERENCE: Preference will be given to candidates with extensive trial and criminal prosecutorial and investigative experience in excess of eighteen (18) years; past supervisory experience over legal and investigative staff; the demonstrated ability to work effectively with a broad cross-section of stakeholders and partners; and substantial experience in managing and/or training prosecutors and law enforcement.

RESUME NOTE: Eligibility determinations will be based upon information presented in resume only. Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide an evaluation indicating its U.S. equivalency prior to the closing date. Failure to do so will result in your ineligibility.
