REQUIREMENTS

EXPERIENCE: Three (3) years of experience in the repair, design, calibration, testing, or operating of complex weighing or measuring devices and auxiliaries or in the inspection of weighing and measuring devices and auxiliaries.

NOTE: College level study in the field of engineering, physics, electronics, or mathematics may be substituted for the indicated experience on a year-for-year basis with thirty (30) semester hour credits being equal to one (1) year of experience.

NOTE: Applicants must have successfully completed the Weights and Measures training program conducted by the State Office of Weights and Measures, Department of Law and Public Safety.

LICENSE: Appointee will be required to possess a driver's license valid in New Jersey.

NOTE: The responsibility for ensuring that employees possess the required motor vehicle license, commensurate with the class and type of vehicle they operate, rests with the Appointing Authority.

RESUME NOTE: Eligibility determinations will be based upon information presented in resume only. Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide an evaluation indicating the U.S. equivalency prior to the closing date. Failure to do so may result in disqualification.
