<u>DUTIES</u>: Under direction of the Director, Division of Consumer Affairs, the Deputy Director over the Professional Boards Unit (Boards) – Investigations and Enforcement is responsible for overseeing all aspects of the Boards' investigative and disciplinary processes. The Deputy Director will oversee complaint review and investigations, and manage enforcement activities for the Professional Boards Unit. The Deputy Director will oversee various units and programs within the Division that perform investigative, analytic, or assessment functions designed to ensure compliance by professional and occupation board licensees with applicable laws and regulations. The position will perform other executive-level functions, as required.

REQUIREMENTS

EDUCATION: Graduation from an accredited college with a Bachelor's degree.

EXPERIENCE: Five (5) years of experience in the administration of government or business operations, three (3) years of which shave have been in a supervisory capacity.

<u>LICENSE</u>: Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.

<u>PREFERENCE</u>: Preference will be given to applicants Juris Degree (JD) and extensive experience in conducting investigations and other compliance activities.
