DUTIES: Under supervision of the Director of Legislative and Regulatory Affairs (DLRA), in the Office of the Director, Division of Consumer Affairs, will analyze pending and enacted legislation affecting the Division, any of its numerous licensing boards, any of the businesses regulated by the Division, or consumers; obtain comments on the legislation from the affected board(s), the Division's Regulated Business Unit or the Office of Consumer Protection (OCP); draft bill analysis for submission by the Director to the Attorney General's Office of Legislative Affairs, including recommendations for amendments and a recommendation whether to support, oppose or be neutral; respond to questions about bill analysis or about amendments to bill; liaise with Executive Director of relevant board or boards or with appropriate OCP personnel for follow up. Under supervision of DLRA, attend meetings of assigned licensing boards and their regulatory committees, or interview OCP personnel, to understand the purpose and effect of amendments to regulations and new regulations sought by the boards or OCP; report and discuss with DLRA and Deputy Director, and, if appropriate, the Director, policy issues presented by the proposal; draft regulations and manage the review and approval process through the publication of a proposal; analyze, summarize, and prepare responses to comments about the proposal submitted by the public and any amendments to the proposal; manage the review and approval process through the publication of the adopted rule; does related work as required.

REQUIREMENTS

EDUCATION: Graduation from an accredited law school with Juris Doctor (J.D.) or a Bachelor of Law (L.L.B) degree
(OR)

EDUCATION: Graduation from an accredited college or university with a Bachelor's degree.

EXPERIENCE: Three (3) years of experience involving legal or legislative research, drafting of rules, regulations, legislation, amendments, and/or the interpretation of statutes.

NOTE: Appointee currently matriculating in an accredited law school as an L.L.B. or JD candidate may substitute such enrollment for the three (3) years of required experience on a year-for-year basis

PREFERENCE: Preference will be given to applicants with legal, legislative or regulatory experience in commercial transactions or consumer fraud matters.

LICENSE: Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.
