#### **NUMBER OF POSITIONS AVAILABLE:** One (1)

**<u>DUTIES:</u>** Under the supervision of the Director of the Division of Criminal Justice, the Legal Chief or Deputy Legal Chief of the Office of Securities Fraud and Financial Crimes Prosecutions (the Office or OSFFCP), or other executive officers in the Office or the Division, the DAG 1/Bureau Chief will help lead OSFFCP's mission to investigate and prosecute significant securities fraud and financial crimes that undermine the fairness and integrity of our financial systems, exploit investors, and prey on vulnerable individuals across the State of New Jersey and beyond. This work involves identifying and developing investigations, evaluating legal issues, assessing evidence and potential criminal charges, and prosecuting criminal actions. The Bureau Chief/DAG 1 is responsible for management and oversight of assigned staff which investigates and prosecutes a variety of cases; this position performs litigation and administrative oversight; represents State departments or other entities prescribed by applicable statutes; participates in the planning, development, and organization of the work programs involved in the detection and prosecution of criminal activities; interprets and enforces laws and regulations; as the Office or the Division's representative, participates in legal and related activities involving federal and local jurisdictions and other State entities and engages in discussions and negotiations with other State and federal agencies; provides direct supervision to assigned staff; conducts case reviews with attorney and detective staff; authors and/or reviews performance assessments of all assigned staff; maintains vast administrative responsibilities; reviews search warrants, communication data warrants, wiretap warrants, communications information orders, prosecution memoranda, plea memoranda and cooperation agreements; oversees trial preparation for cases assigned to the Office; maintains a case list and litigates cases, as needed or required; oversees Division and/or Office initiatives and trainings; maintains effective communication with Office, Division, and Department of Law and Public Safety (LPS) leadership; serves on various task forces and working groups for the Division, Office, or LPS; works on special projects and initiatives; and performs other related work as required.

#### REQUIREMENTS

**EDUCATION:** Graduation from an accredited law school with a Juris Doctor. Admission to practice as an Attorney at Law in the State of New Jersey is required.

**EXPERIENCE:** Five (5) years of experience as a practicing attorney, two (2) years of which shall have been in a supervisory capacity.

**LICENSE:** Appointee will be required to possess a driver's license valid in New Jersey.

**PREFERENCE:** Preference will be given to candidates with experience in criminal prosecution, specifically related to crimes prosecuted by OSFFCP; supervisory and leadership experience; extensive criminal trial experience; demonstrated ability to work effectively with a broad cross-section of stakeholders; must possess excellent written and oral communications skills; and demonstrated experience in bringing or defending complex securities or financial litigation, by those who possess subject matter knowledge regarding the purchase and sale of securities and commodities and the applicable laws, rules, and regulations.

**RESUME NOTE:** Eligibility determinations will be based upon information presented in resume only. Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide an evaluation indicating its U.S. equivalency prior to the closing date. Failure to do so will result in your ineligibility.

All offers of employment are conditional subject to the applicant agreeing to and then passing a background check that may include fingerprinting.
