<u>DUTIES</u>: Under direction of the Department's Chief Ethics & Compliance Officer and Deputy Chief Ethics & Compliance Officer, will provide legal support to the Office of Ethics & Compliance. The DAG, Ethics & Compliance, will assist in the execution of compliance reviews, employee-related internal investigations and internal audits. This individual will oversee and coordinate the work of the network of Ethics Liaison Officers in the Department, and will serve as an Ethics Liaison Officer for the Division of Administration and Office of the Attorney General; performs other related duties as required.

## REQUIREMENTS

**EDUCATION:** Graduation from an accredited law school with a Juris Doctor. Admission to practice as an Attorney at Law in the State of New Jersey is required.

**EXPERIENCE:** Four (4) years of experience as a practicing attorney, one (1) year of which shall have been in a supervisory capacity.

**LICENSE:** Appointee will be required to possess a driver's license valid in New Jersey.

<u>PREFERENCE:</u> Preference will be given to attorneys who have experience performing investigations, writing or reviewing investigative reports, and with application of government policies, rules and regulations. Preference will also be given to attorneys who have experience interpreting the Uniform Ethics Code, Conflicts of Interest Law and Rules of Professional Conduct.
