**NUMBER OF POSITIONS AVAILABLE:** One (1) – Location preference is required

<u>DUTIES</u>: Under the general supervision of a supervisory official in a state department, institution or agency, or in a local jurisdiction, directly supervises professional and/or technical staff engaged in program activities; performs the more complex and sensitive professional, administrative and analytical work to promote the planning, operation, implementation, monitoring and evaluation of various programs and services administered by the Department of assignment; conducts the research and field work necessary to meet the needs of the appropriate state and/or local public or private agencies; prepares and signs official performance evaluations for subordinate staff; does other related work. This position may also require non-traditional work hours, on an as needed basis, including evenings and weekends on short deadlines for certain assignments, with or without advance notice, and may require travel to perform the aforementioned responsibilities. #### REQUIREMENTS

**NOTE:** Applicants must meet one of the following or a combination of both experience and education. Thirty (30) semester hour credits are equal to one (1) year of relevant experience.

Seven (7) years of professional experience in planning, monitoring, coordinating, implementing, modifying, and/or evaluating agency programs and services.

## <u>OR</u>

Possession of a bachelor's degree from an accredited college or university; and three (3) years of the above-mentioned professional experience.

# <u>OR</u>

Possession of a master's degree from an accredited college or university in a discipline appropriate to the position; and two (2) years of the above-mentioned professional experience.

**<u>NOTE</u>**: "Professional experience" refers to work that is creative, analytical, evaluative, and interpretive; requires a range and depth of specialized knowledge of the profession's principles, concepts, theories, and practices; and is performed with the authority to act according to one's own judgment and make accurate and informed decisions.

**LICENSE:** Appointee will be required to possess a driver's license valid in New Jersey.

**PREFERENCE:** Preference will be given to candidates with strong organizational skills; a propensity for innovative problem solving; the ability to multitask and work successfully and collaboratively with various stakeholder groups; experience in community leadership, having worked with nonprofit, social/human services, or governmental organizations; and, the ability to meet short-term and long-term timelines in an ever-shifting landscape. Experience working in the fields of anti-violence, social justice, victims'/survivors' rights, trauma-informed services, and/or policy creation are also preferred.
