<u>DUTIES</u>: Under the general supervision of a supervisory official in the Division of State Police, Department of Law and Public Safety, provides front-line and behind the scenes customer and other support services involving the review, processing and issuance of agency documents specific to the criminal expungement process; provides specialized information to applicants, and others, regarding expungement process; handles highly complex and/or sensitive expungement processes, requests and complaints; functions in a lead worker capacity and provides guidance and assistance to lower level staff; does other related duties as required.

## REQUIREMENTS

**EXPERIENCE:** Four (4) years of experience, in expungement related activities, providing information and support and conducting computer inquiries against criminal and/or court related databases and public related inquiries.

**LICENSE:** Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.
