**DUTIES:** Under the direction of an administrative official in the Division of State Police, Department of Law and Public Safety, organizes and ensures operational efficiency of the unit; and supervises unit members responsible for all phases of the expungement process. This includes specialized information to applicants, and others, regarding the expungement process; provides information to applicants and others regarding the expungement process; handles the more complex and/or sensitive expungement processes, requests and complaints; supervises staff and work activities; prepares and signs official performance evaluations for subordinate staff; does other related duties as required.

### **REQUIREMENTS**

**EXPERIENCE:** Six (6) years of experience in expungement related activities, including but not limited to the review, processing, filing, modification, correction and/or research of records, criminal histories, and other documents used by state, local and federal law enforcement agencies during the expungement process, and conducting computer inquiries against criminal and/or court related databases and public related inquiries. One year (1) of which shall have been in a supervisory capacity.

**LICENSE:** Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.

**RESUME NOTE:** Eligibility determinations will be based upon information presented in the resume only. Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide an evaluation indicating the U.S. equivalency prior to the closing date. Failure to do so will result in your ineligibility.
