DUTIES: Under the supervision of a Supervisor 2, Expungement or other higher-level supervisory official in the Division of State Police, Department of Law and Public Safety, supervises unit members responsible for all phases of the expungement process. This includes specialized information to applicants, and others, regarding expungement process; provides information to applicants and others regarding the expungement process; handles sensitive expungement processes, requests, and complaints; supervises staff and work activities; prepares and signs official performance evaluations for subordinate staff; does other related duties as required.

REQUIREMENTS

EXPERIENCE: Five (5) years of experience in expungement related activities, including but not limited to the review, processing, filing, modification, correction and/or research of records, criminal histories, and other documents used by state, local and federal law enforcement agencies during the expungement process, and conducting computer inquiries against criminal and/or court related databases and public related inquiries.

LICENSE: Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.

RESUME NOTE: Eligibility determinations will be based upon information presented in the resume only. Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide an evaluation indicating the U.S. equivalency prior to the closing date.
