**DUTIES:** Under supervision of a Crew Supervisor, Plumbers and Steamfitters, or other supervisor in a state department, institution, or agency, does varied types of plumbing work involved in the installation, repair, and maintenance of plumbing and steamfitting fixtures, fittings, and systems; does other related duties as required. ## **REQUIREMENTS**

**EXPERIENCE:** Three (3) years of broad experience in work involving the installation, inspection, repair, and maintenance of plumbing and steamfitting fixtures, fittings appliances, machinery, and plumbing systems.

**LICENSE**: Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.

**<u>RESUME NOTE</u>**: Eligibility determinations will be based upon information presented in resume only. Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide an evaluation indicating the U.S. equivalency prior to the closing date. Failure to do so may result in your ineligibility.

All offers of employment are conditional subject to the applicant agreeing to and then passing a background check that may include fingerprinting.
