DUTIES: Under supervision, inspects photography equipment and accessories for operability, determines techniques needed for each photography assignment; reviews digital photographic images and photographic proofs; records and monitors the use of material, equipment, parts or supplies; copies negatives from flat art or photographs; corrects flaws in digital images, prints or negatives; applies established security procedures and guidelines; edits written material; estimates necessary quantity of time, costs, materials or personnel necessary to accomplish assignments or goals; implements maintenance procedures for work areas; designs digital charts and graphs; files records; examines documents for adherence to applicable laws and regulations; conducts research and study programs; operates digital still picture and video cameras; operates film processing equipment; selects camera lens set-ups and design arrangements for photography assignments; mixes developing and fixing solutions for film processing; develops black-and-white or color film; makes black-and-white or color prints from negatives; arranges perishable stock by date received; operates a motor vehicle; communicate via telephone or email; answer questions about application of regulations or policies; will photographically document items of evidence related to criminal investigations, traffic / accident investigations; possess a working knowledge of Adobe Photoshop, Adobe Premier Pro and Adobe Light Room; video enhancement training and knowledge is preferred; printing of digital photographic images; matting and framing of photographs; required to complete the photographic documentation of New Jersey State Police enlisted and civilian personnel for identification purposes; required to work some evenings, weekends, and occasional holidays; required to work photographic details outside of the office for New Jersey State Police functions some of which are held during evening hours, weekends and or on occasional holidays.

REQUIREMENTS

EDUCATION: Completion of a vocational, technical or specialized training program photography or photographic technology.

EXPERIENCE: One (1) year of professional experience in taking digital photographs, processing digital photographs, and printing digital photographs.

NOTE: Applicants who do not possess the required education may substitute one (1) year of additional nonsupervisory experience.

LICENSE: Appointee will be required to possess a driver's license valid in the State of New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.

RESUME NOTE: Eligibility determinations will be based upon information presented in resume only. Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide an evaluation indicating the U.S. equivalency prior to the closing date. Failure to do so will result in your ineligibility.
