DUTIES: Under direction of a supervisory official in the Youth Justice Commission, conducts varied types of social investigations; assesses needs, situations, strengths, and support networks to determine goals; develops plans to improve the wellbeing of youth; help clients adjust to changes and challenges in their lives; researches and refers clients to community resources; helps clients work with government agencies to apply for and receive benefits; responds to crisis situations; evaluates services provided to ensure that they are effective; does related work as required. REQUIREMENTS

EDUCATION: Graduation from an accredited college or university with a Master's degree in Social Work.

EXPERIENCE: One (1) year of experience in social case work, which shall have involved the responsibility for gathering and analyzing social information from clients, the determination of their needs, and the planning and administration of treatment plans geared toward the needs of individual clients.

<u>NOTE</u>: A Master's degree in Social Work including or supplemented by a supervised field placement accredited by the Council on Social Work Education may be substituted for the above stated experience requirements.

LICENSE: Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.

<u>RESUME NOTE</u>: Eligibility determinations will be based upon information presented in resume only. Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide an evaluation indicating the U.S. equivalency prior to the closing date. Failure to do so may result in your ineligibility.

All offers of employment are conditional subject to the applicant agreeing to and then passing a background check that may include fingerprinting.
