ANTHONY PETRUCCI)

The Grand Jurors of and for the State of New Jersey,
upon their oaths, present that:

COUNT ONE

(Possession with Intent to Distribute a Controlled
Dangerous Substance - First Degree)

ANTHONY PETRUCCI

on or about February 14, 2006, at the Township of Springfield, in
the County of Burlington, elsewhere and within the jurisdiction
of this Court, knowingly did have in his possession a controlled
dangerous substance, to wit: Methamphetamine, in an amount of
five ounces or more, with the intent to distribute it, contrary
to the provisions of N.J.S.A. 2C:35-5b(8), and against the peace
of this State, the government and dignity of same.

COUNT TWO

(Distribution of a Controlled Dangerous Substance - Second Degree)

ANTHONY PETRUCCI

on or about February 14, 2006, at the Township of Springfield, in the County of Burlington, elsewhere and within the jurisdiction of this Court, knowingly did distribute a controlled dangerous substance, to wit: Methamphetamine, in an amount of more than one half ounce and less than five ounces, contrary to the provisions of N.J.S.A. 2C:35-5b(9)(a), and against the peace of this State, the government and dignity of same.

COUNT THREE

(Distribution of a Controlled Dangerous Substance - Second Degree)

ANTHONY PETRUCCI

on or about January 5, 2006, at the Township of Springfield, in the County of Burlington, elsewhere and within the jurisdiction of this Court, knowingly did distribute a controlled dangerous substance, to wit: Methamphetamine, in an amount of more than one half ounce and less than five ounces, contrary to the provisions of N.J.S.A. 2C:35-5b(9)(a), and against the peace of this State, the government and dignity of same.

COUNT FOUR

(Possession of a Weapon while Committing Certain Controlled Dangerous Substances Offenses - Second Degree)

ANTHONY PETRUCCI

on or about February 14, 2006, at the Township of Springfield, in the County of Burlington, elsewhere and within the jurisdiction of this Court, knowingly did have in his possession a firearm, to wit: a SIG semi-automatic handgun, while in the course of committing, attempting to commit, or conspiring to commit a violation of N.J.S.A. 2C:35-5, contrary to the provisions of N.J.S.A. 2C:39-4.1a, and against the peace of this State, the government and dignity of the same.

COUNT FIVE

(Possession of a Controlled Dangerous Substance - Third Degree)

ANTHONY PETRUCCI

on or about January 5, 2006, at the Township of Springfield, in the County of Burlington, elsewhere and within the jurisdiction of this Court, knowingly did have in his possession a controlled dangerous substance, to wit: Methamphetamine, contrary to the provisions of N.J.S.A. 2C:35-10a(1), and against the peace of this State, the government and dignity of the same.

COUNT SIX

(Possession of a Controlled Dangerous Substance - Third Degree)

ANTHONY PETRUCCI

on or about February 14, 2006, at the Township of Springfield, in the County of Burlington, elsewhere and within the jurisdiction of this Court, knowingly did have in his possession a controlled dangerous substance, to wit: Methamphetamine, contrary to the provisions of N.J.S.A. 2C:35-10a(1), and against the peace of this State, the government and dignity of the same.

COUNT SEVEN


(Possession of a Controlled Dangerous Substance - Third Degree)
