The Grand Jurors of and for the State of New Jersey, upon their oaths, present that:

COUNT ONE

(Racketeering Conspiracy - Second Degree)

KYLE J. BUNN

RONALD RASHEEM CROSLAND

JAMAR LEVI DOGGETT

JAESEN HENSLEY

and

JOHN EDWARD-WESLEY WHITE, JR.

and other persons whose identities are both known and unknown to the Grand Jurors, who are named as co-conspirators but not as defendants herein, at the times and places herein specified, with the purpose of promoting and facilitating the commission of the crime of racketeering, did commit the crime of conspiracy, that is, the defendants and the unindicted co-conspirators did agree that:

A. One or more of them knowingly would engage in conduct which would constitute the crime of racketeering, and

B. One or more of them knowingly would aid in the planning, solicitation and commission of the crime of racketeering, that is, the defendants and one or more of the unindicted coconspirators, being persons employed by or associated with an enterprise, which enterprise was engaged in and the activities of which affected trade or commerce, would conduct and participate, directly or indirectly, in the conduct of the enterprise's affairs through a pattern of racketeering activity, in violation of <u>N.J.S.A.</u> 2C:41-2c, all as hereinafter described.

THE RELEVANT TIMES

1. The conspiracy occurred between in or about 2003, and in or about May 4, 2005.

THE RELEVANT PLACES

2. The conspiracy took place at the Township of

Hamilton, in the County of Atlantic; at the Township of Burlington, at the Township of Eastampton, at the Township of Evesham, at the Township of Florence, at the Township of Hainesport, at the Township of Mount Holly, at the Township of Pemberton, and at the Township of Willingboro, all in the County of Burlington; at the Borough of Lindenwold, at the Township of Pennsauken, and at the Borough of Runnemede, all in the County of Camden; at the City of Trenton, in the County of Mercer; elsewhere and within the jurisdiction of this Court.

THE ENTERPRISE

3. KYLE J. BUNN, RONALD RASHEEM CROSLAND, JAMAR LEVI DOGGETT, JAESEN HENSLEY, AND JOHN EDWARD-WESLEY WHITE, JR., and other persons whose identities are both known and unknown to the Grand Jurors, would constitute an enterprise within the meaning of <u>N.J.S.A.</u> 2C:41-1c, that is, a group of individuals associated in fact which would plan, solicit and commit the thefts, sales, alterations of the vehicle identification numbers and misrepresentations on motor vehicle titles of motorcycles and all-terrain vehicles.

THE PURPOSES OF THE ENTERPRISE

4. It was a part of the conspiracy that the purposes of the enterprise would include the theft and sale of motorcycles and all-terrain vehicles throughout central and southern New Jersey. The individual members of the enterprise described

herein would execute a common plan and scheme, acting in concert, by scouting desirable motorcycles and all-terrain vehicles, contacting other members to assist in the theft, and committing the theft with vans owned by a member or stolen for that purpose. The enterprise members would transact directly the motorcycle or all-terrain vehicle for cash, either splitting the proceeds or retaining another vehicle. Other enterprise members also would act as secondary fences, transacting the same motorcycles again for cash. It was a further purpose of the enterprise to take affirmative steps to thwart detection or apprehension by law enforcement, including the alteration of the vehicle identification numbers and misrepresentations on motor vehicle Said conduct would be executed for the purpose of titles. acquiring cash and other benefits for members and associates of the enterprise primarily in the following ways:

A. By engaging in repeated acts of theft by unlawful taking through a common scheme or course of conduct by unlawfully taking or exercising unlawful control over the movable property of others, that is, motorcycles and all-terrain vehicles, having a value in excess of \$500, with the purpose to deprive the owners thereof, in violation of N.J.S.A. 2C:20-3.

B. By engaging in repeated acts of receiving stolen property through a common scheme or course of conduct by knowingly receiving or bringing into this State movable property

of another, that is, motorcycles and all-terrain vehicles, having a value in excess of \$500, knowing the same to be stolen or believing that it was probably stolen, in violation of <u>N.J.S.A.</u> 2C:20-7.

C. By engaging in repeated acts of fencing through a common scheme or course of conduct by knowingly trafficking, initiating, organizing, planning, financing, directing, managing, or supervising the trafficking in stolen property, that is, motorcycles and all-terrain vehicles, having a value in excess of \$500, in violation of <u>N.J.S.A.</u> 2C:20-7.1.

D. By engaging in repeated acts of alteration of vehicle identification number through a common scheme or course of conduct by knowingly removing, defacing, altering, changing, destroying, covering or obliterating any trademark, distinguishing or identification number, serial number or mark on motorcycles and all-terrain vehicles, for an unlawful purpose, in violation of N.J.S.A. 2C:17-6.

E. By engaging in repeated acts of motor vehicle title offense through a common scheme or course of conduct by purposely or knowingly making a misrepresentation or false statement in title papers or other papers submitted to the Chief Administrator of the New Jersey Motor Vehicle Commission in connection therewith for motorcycles, in violation of <u>N.J.S.A.</u> 2C:21-4.8.

THE PATTERN OF RACKETEERING ACTIVITY

5. The pattern of racketeering activity, as defined in <u>N.J.S.A.</u> 2C:41-1d, would consist of at least two incidents of racketeering activity, including theft by unlawful taking (<u>N.J.S.A.</u> 2C:20-3), receiving stolen property (<u>N.J.S.A.</u> 2C:20-7), fencing (<u>N.J.S.A.</u> 2C:20-7.1), alteration of vehicle identification number (<u>N.J.S.A.</u> 2C:17-6), and motor vehicle title offense (<u>N.J.S.A.</u> 2C:21-4.8), all as described herein and in Counts Three through Thirty-Nine of this Indictment.

All in violation of N.J.S.A. 2C:41-2d and N.J.S.A.2C:5-2, and against the peace of this State, the government and dignity of the same.

COUNT TWO

(Racketeering - Second Degree)

KYLE J. BUNN

RONALD RASHEEM CROSLAND

JAMAR LEVI DOGGETT

JAESEN HENSLEY

and

JOHN EDWARD-WESLEY WHITE, JR.

and other individuals both known and unknown to the Grand Jurors, who are named as co-conspirators in this Indictment but not as defendants in this Count, between in or about 2003, and in or about May 4, 2005, at the Township of Hamilton, in the County of Atlantic; at the Township of Burlington, at the Township of Eastampton, at the Township of Evesham, at the Township of Florence, at the Township of Hainesport, at the Township of Mount Holly, at the Township of Pemberton, and at the Township of Willingboro, all in the County of Burlington; at the Borough of Lindenwold, at the Township of Pennsauken, and at the Borough of Runnemede, all in the County of Camden; at the City of Trenton, in the County of Mercer; elsewhere and within the jurisdiction of this Court, did commit the crime of racketeering, that is, the defendants and other persons employed by and associated with an enterprise engaged in and the activities of which affected trade and commerce, purposely and knowingly did conduct and participate

directly and indirectly, in the conduct of the enterprise's affairs through a pattern of racketeering activity.

The Enterprise

KYLE J. BUNN, RONALD RASHEEM CROSLAND, JAMAR LEVI DOGGETT, JAESEN HENSLEY and JOHN EDWARD-WESLEY WHITE, JR., and other persons whose identities are both known and unknown to the Grand Jurors, would constitute an enterprise within the meaning of <u>N.J.S.A.</u> 2C:41-1c, that is, a group of individuals associated in fact which would plan, solicit and commit the thefts, sales, alterations of the vehicle identification numbers and misrepresentations on motor vehicle titles of motorcycles and all-terrain vehicles. The purposes of the enterprise are set forth in Count One of this Indictment and incorporated herein as though fully set forth.

The Pattern of Racketeering Activity

The pattern of racketeering activity, as defined in <u>N.J.S.A.</u> 2C:41-1d, did consist of at least two incidents of racketeering conduct, including theft by unlawful taking (<u>N.J.S.A.</u> 2C:20-3), receiving stolen property (<u>N.J.S.A.</u> 2C:20-7), fencing (<u>N.J.S.A.</u> 2C:20-7.1), alteration of vehicle identification number (<u>N.J.S.A.</u> 2C:17-6), and motor vehicle title offense (<u>N.J.S.A.</u> 2C:21-4.8), all as described herein and in Counts Three through Thirty-Nine of this Indictment.

KYLE J. BUNN

did commit the racketeering conduct of attempted theft by unlawful taking, theft by unlawful taking, receiving stolen property, fencing, alteration of vehicle identification number, and motor vehicle title offense, all of which is the subject of Counts 3, 4, 5, 6, 7, 8, 16, 18, 19, 22, and 32 of this Indictment, as well as other prior conduct.

RONALD RASHEEM CROSLAND

did commit the racketeering conduct of attempted theft by unlawful taking, theft by unlawful taking, and fencing, all of which is the subject of Counts 3, 4, 5, 9, 10, 11, 12, 13, 14, 15, and 17 of this Indictment, as well as other prior conduct.

JAMAR LEVI DOGGETT

did commit the racketeering conduct of theft by unlawful taking, receiving stolen property, and fencing, all of which is the subject of Counts 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 32, and 35 of this Indictment, as well as other prior conduct.

JAESEN HENSLEY

did commit the racketeering conduct of receiving stolen property, fencing, alteration of vehicle identification number, and motor vehicle title offense, all of which is the subject of Counts 33, 34, 36, 37, 38, and 39 of this Indictment, as well as other prior conduct.

JOHN EDWARD-WESLEY WHITE, JR.

did commit the racketeering conduct of theft by unlawful taking,

receiving stolen property, attempted fencing, alteration of vehicle identification number, and motor vehicle title offense, all of which is the subject of Counts 26, 28, 29, 30, and 31 of this Indictment, as well as other prior conduct.

All in violation of <u>N.J.S.A.</u> 2C:41-2c and <u>N.J.S.A.</u> 2C:2-6, and against the peace of this State, the government and dignity of the same.

FORFEITURES

1. All allegations of Count One of this Indictment are hereby incorporated by reference and re-alleged as if fully set forth herein, for the purpose of alleging forfeitures pursuant to <u>N.J.S.A.</u> 2C:41-3b.

2. The defendants have property constituting:

A. Interests, including money and other things of value, acquired and maintained in violation of <u>N.J.S.A.</u> 2C:41-2c, and

B. Interests in the enterprise specified herein, which the said defendants established, acquired, maintained, operated, controlled, conducted, and participated in the conduct of, in violation of <u>N.J.S.A.</u> 2C:41-2c.

3. The said interests, all subject to forfeiture to the State of New Jersey, include, but are not limited to, the following:

COUNT THREE

(Attempted Theft by Unlawful Taking - Third Degree)

KYLE J. BUNN

and

RONALD RASHEEM CROSLAND

on or about May 13, 2004, at the Township of Pennsauken, in the County of Camden, elsewhere and within the jurisdiction of this Court, did purposely attempt to unlawfully take or exercise unlawful control over movable property of another in excess of \$500.00 with purpose to deprive the owner thereof; that is, the said KYLE J. BUNN and RONALD RASHEEM CROSLAND did purposely attempt to unlawfully take or exercise unlawful control over one 1999 Honda CBR 600 motorcycle, Vehicle Identification Number JH2PC3502XM000088, in excess of \$500.00, with purpose to deprive the owner thereof, contrary to the provisions of <u>N.J.S.A.</u> 2C:20-3, <u>N.J.S.A.</u> 2C:5-1, and <u>N.J.S.A.</u> 2C:2-6, and against the peace of this State, the government and dignity of the same.

COUNT FOUR

(Theft by Unlawful Taking - Third Degree)

(Fencing - Third Degree)

between on or about December 6, 2003, and on or about December 15, 2003, at the Township of Willingboro, in the County of Burlington, elsewhere and within the jurisdiction of this Court, did knowingly traffic in, or initiate, organize, plan, finance, direct, manage, or supervise trafficking in stolen property in excess of \$500.00; that is, the said KYLE J. BUNN and RONALD RASHEEM CROSLAND did knowingly traffic in, or initiate, organize, plan, finance, direct, manage, or supervise trafficking in one 2003 Yamaha R6 motorcycle, Vehicle Identification Number JYARJ06E73A005598, in excess of \$500.00, reported stolen on December 6, 2003, to the Evesham Township Police Department, contrary to the provisions of <u>N.J.S.A.</u> 2C:20-7.1 and <u>N.J.S.A.</u> 2C:2-6, and against the peace of this State, the government and dignity of the same.

COUNT SIX

(Alteration of Vehicle Identification Number - Third Degree)

KYLE J. BUNN

between on or about December 6, 2003, and on or about December 15, 2003, at the Township of Willingboro, in the County of Burlington, elsewhere and within the jurisdiction of this Court, did knowingly remove, deface, alter, change, destroy, cover or obliterate any trademark, distinguishing or identification number, serial number or mark on or from any motor vehicle for an. unlawful purpose; that is, the said KYLE J. BUNN did knowingly alter the Vehicle Identification Number on one 2003 Yamaha R6 motorcycle, from JYARJ06E73A005598 to JYARJ04E11A017083, for the unlawful purpose of concealing the theft of that motorcycle, contrary to the provisions of <u>N.J.S.A.</u> 2C:17-6a, and against the peace of this State, the government and dignity of the same.

COUNT SEVEN

(Motor Vehicle Title Offense - Third Degree)

KYLE J. BUNN

on or about December 15, 2003, at the Township of Willingboro, in the County of Burlington, elsewhere and within the jurisdiction of this Court, did purposely or knowingly misrepresent a number placed on a motor vehicle by the manufacturer, or in any other manner misrepresent the description of a motor vehicle in a title paper; that is, the said KYLE J. BUNN, did purposely or knowingly misrepresent one 2003 Yamaha R6 motorcycle, Vehicle Identification Number JYARJ06E73A005598, as a 2001 Yamaha R6 motorcycle, Vehicle Identification Number JYARJ04E11A017083, in a title paper, contrary to the provisions of <u>N.J.S.A.</u> 2C:21-4.8, and against the peace of this State, the government and dignity of the same.

COUNT EIGHT

(Alteration of Vehicle Identification Number - Third Degree)

KYLE J. BUNN

on or about April 25, 2005, at the Township of Willingboro, in the County of Burlington, elsewhere and within the jurisdiction of this Court, did knowingly remove, deface, alter, change, destroy, cover or obliterate any trademark, distinguishing or identification number, serial number or mark on or from any motor vehicle for an unlawful purpose; that is, the said KYLE J. BUNN did knowingly alter the Vehicle Identification Number on one 2004 Kawasaki ZX 636 motorcycle, from JKBZXJB144A029215 to JKAZX4J112A051340, for the unlawful purpose of concealing the theft of that motorcycle, contrary to the provisions of <u>N.J.S.A.</u> 2C:17-6a, and against the peace of this State, the government and dignity of the same.

COUNT NINE

(Fencing - Third Degree) RONALD RASHEEM CROSLAND

on or about June 1, 2004, at the Township of Pennsauken, in the County of Camden, elsewhere and within the jurisdiction of this Court, did knowingly traffic in, or initiate, organize, plan, finance, direct, manage, or supervise trafficking in stolen property in excess of \$500.00; that is, the said RONALD RASHEEM CROSLAND did knowingly traffic in, or initiate, organize, plan, finance, direct, manage, or supervise trafficking in one 2003 Honda CBR 600RR motorcycle, Vehicle Identification Number JH2PC37063M004300, in excess of \$500.00, reported stolen on December 13, 2003, to the Hammonton Township Police Department, contrary to the provisions of <u>N.J.S.A.</u> 2C:20-7.1 and <u>N.J.S.A.</u> 2C:2-6, and against the peace of this State, the government and dignity of the same.

BUNN did knowingly alter the Vehicle Identification Number on one 2004 Honda CBR 600RR motorcycle, from JH2PC37034M102959 to JH2PC37013M005421, for the unlawful purpose of concealing the theft of that motorcycle, contrary to the provisions of <u>N.J.S.A.</u> 2C:17-6a, and against the peace of this State, the government and dignity of the same.

COUNT SEVENTEEN

(Fencing - Third Degree) RONALD RASHEEM CROSLAND

between on or about February 16, 2005, and on or about February 17, 2005, at the Township of Willingboro, in the County of Burlington, elsewhere and within the jurisdiction of this Court, did knowingly traffic in, or initiate, organize, plan, finance, direct, manage, or supervise trafficking in stolen property in excess of \$500.00; that is, the said RONALD RASHEEM CROSLAND did knowingly traffic in, or initiate, organize, plan, finance, direct, manage, or supervise trafficking in one 2000 Yamaha R6 motorcycle, Vehicle Identification Number JYARJ04E2YA009570, in excess of \$500.00, reported stolen on August 13, 2000, to the Florence Township Police Department, contrary to the provisions of <u>N.J.S.A.</u> 2C:20-7.1 and <u>N.J.S.A.</u> 2C:2-6, and against the peace of this State, the government and dignity of the same.

COUNT EIGHTEEN

(Theft by Unlawful Taking - Third Degree)

JAMAR LEVI DOGGETT

on or about April 26, 2005, at the Township of Eastampton, in the County of Burlington, elsewhere and within the jurisdiction of this Court, did unlawfully take or exercise unlawful control over movable property of another in excess of \$500.00 with purpose to deprive the owner thereof; that is, the said KYLE J. BUNN and JAMAR LEVI DOGGETT did unlawfully take or exercise unlawful control over one 2005 Honda CBR 1000RR motorcycle, Vehicle Identification Number JH2SC57005M100495, in excess of \$500.00, with purpose to deprive the owner thereof, contrary to the provisions of <u>N.J.S.A.</u> 2C:20-3 and <u>N.J.S.A.</u> 2C:2-6, and against the peace of this State, the government and dignity of the same.

(Fencing - Third Degree)
