(Theft of Services - Third Degree)



September 13, 2006, at the Townships of New Brunswick, Edison,  
Woodbridge, Carteret, Old Bridge, and Monroe, and at the City of  
Perth Amboy, all in the County of Middlesex, at the Townships of  
East Windsor and Washington, both in the County of Mercer, at the  
City of Newark, in the County of Essex, at the City of Elizabeth,  
in the County of Union, at the City of Asbury Park, and at the  
Borough of Belmar, both in the County of Monmouth, at the  
Townships of Brick, Lakewood, Dover, Lacy, Barnegat, and


