The Grand Jurors of and for the State of New Jersey, upon
their oaths, present that:

COUNT ONE

(Conspiracy - Second Degree)

JAMES MCKOY

ROY HARTE

SHARON VANESSA PHILLIPS

DONALD H. GIDDINGS

and

GARY L. BROWN

between on or about June 27, 2007, and on or about July 6, 2007, at the Township of Woodbridge, in the County of Middlesex, at the Township of Secaucus, in the County of Hudson, at the Townships of Parsippany-Troy Hills and Dover, both in the County of Morris, at the City of Fairfield, in the County of Essex, in the State of Arizona, elsewhere, and within the jurisdiction of the Court, with the purpose of promoting or facilitating the commission of the crimes of distribution of a controlled dangerous substance and possession with intent to distribute a controlled dangerous substance, did agree that:

A. One or more of them knowingly would engage in conduct which would constitute the aforesaid crimes, or

B. One or more of them knowingly would aid in the planning, solicitation or commission of said crimes, that is:

1. Knowingly or purposely to distribute a controlled dangerous substance, that is, marijuana, in a quantity of twenty five pounds or more including any adulterants or dilutants, contrary to the provisions of N.J.S.A. 2C:35-5a(1) and N.J.S.A. 2C:35-5b(10) (a).

2. Knowingly or purposely to possess with intent to distribute a controlled dangerous substance, that is, marijuana, in a quantity of five ounces or more including any adulterants or

dilutants, contrary to the provisions of N.J.S.A. 2C:35-5a(1) and N.J.S.A. 2C:35-5b(10) (a) .

All in violation of N.J.S.A. 2C:5-2, and against the peace of this State, the government and dignity of the same.



Federal Express Ground, as follows:


