COUNT ONE

(Endangering the Welfare of a Child)

(Distribution of Child Pornography - Second Degree)

SEAN S. TURNER

on or about July 30, 2007, at the Township of Highland Lakes, in the County of Sussex, elsewhere and within the jurisdiction of this Court, did knowingly sell, give, provide, lend, trade, mail, deliver, transfer, publish, distribute, circulate, disseminate, present, exhibit, advertise, offer or agree to offer, through any means, including the Internet, a photograph, film, videotape, computer program(s) or file(s), or any other reproduction or reconstruction, which depicts a child engaging in a prohibited sexual act or in the simulation of such an act as defined by N.J.S.A. 2C:24-4b(1), that is, the said SEAN S. TURNER provided an image depicting a child engaging in a prohibited sexual act to a Detective from the New Jersey State Police Digital Technology Investigations Unit over the Internet, contrary to the provisions

of N.J.S.A. 2C:24-4b(5)(a), and against the peace of this State, the government and dignity of the same.

COUNT TWO

(Endangering the Welfare of a Child)

(Distribution of Child Pornography - Second Degree)

SEAN S. TURNER

between on or about July 30, 2007 and on or about September 24, 2007, at the Township of Highland Lakes, in the County of Sussex, elsewhere and within the jurisdiction of this Court, did knowingly sell, give, provide, lend, trade, mail, deliver, transfer, publish, distribute, circulate, disseminate, present, exhibit, advertise, offer or agree to offer, through any means, including the Internet, a photograph, film, videotape, computer program(s) or file(s), or any other reproduction or reconstruction, which depicts a child engaging in a prohibited sexual act or in the simulation of such an act as defined by N.J.S.A. 2C:24-4b(1), that is, the said SEAN S. TURNER offered or agreed to offer an image or video depicting a child engaging in a prohibited sexual act, contrary to the provisions of N.J.S.A. 2C:24-4b(5)(a), and against the peace of this State, the government and dignity of the same.

COUNT THREE

(Endangering the Welfare of a Child)

(Possession of Child Pornography - Fourth Degree)

SEAN S. TURNER

between on or about July 30, 2007, and on or about September 24, 2007, at the Township of Highland Lakes, in the County of Sussex, elsewhere and within the jurisdiction of this Court, did knowingly possess or knowingly view any photograph(s), computer program(s) or file(s)depicting children engaged in prohibited sexual acts or in the simulation of such acts as defined by N.J.S.A. 2C:24-4b(1), including on the Internet, and also contained on computer media, contrary to the provisions of N.J.S.A. 2C:24-4b(5)(b), and against the peace of this State, the government and dignity of the same.
