

their oaths, present that:

COUNT ONE

(Attempted Endangering the
Welfare of a child - Third Degree)

COLBY NOLAN MAULDIN

on or about January 19, 2008, at the Township of Berlin, in the
County of Camden, elsewhere, and within the jurisdiction of this
Court, did purposely attempt to engage in sexual conduct which
would impair or debauch the morals of "kellygirlnj81," contrary
to the provisions of N.J.S.A. 2C:5-1 and N.J.S.A. 2C:24-4a, and
against the peace of this State, the government and dignity of
the same.

COUNT TWO

(Obscenity for Persons under 18, Attempt - Third Degree)

COLBY NOLAN MAULDIN

on or about January 19, 2008, at the Township of Berlin, in the County of Camden, elsewhere, and within the jurisdiction of this Court, did attempt to knowingly exhibit to a person under 18 years of age obscene material, in that, he did transmit an image, picture, or other representation of his penis over the internet to "kellygirlnj81," contrary to the provisions of N.J.S.A. 2C:34-3b(1), and N.J.S.A. 2C:5-1, and against the peace of this State, the government and dignity of the same.

COUNT THREE

(Attempted Endangering the
Welfare of a child - Third Degree)

COLBY NOLAN MAULDIN

on or about January 26, 2008, at the Township of Berlin, in the County of Camden, elsewhere, and within the jurisdiction of this Court, did purposely attempt to engage in sexual conduct which would impair or debauch the morals of "Amanda Tyler," contrary to the provisions of N.J.S.A. 2C:5-1 and N.J.S.A. 2C:24-4a, and against the peace of this State, the government and dignity of the same.

COUNT FOUR

(Obscenity for Persons under 18, Attempt - Third Degree)

COLBY NOLAN MAULDIN

on or about January 26, 2008, at the Township of Berlin, in the County of Camden, elsewhere, and within the jurisdiction of this Court, did attempt to knowingly exhibit to a person under 18 years of age obscene material, in that, he did transmit an image, picture, or other representation of his penis over the internet to "Amanda Tyler," contrary to the provisions of N.J.S.A. 2C:34-3b(1), and N.J.S.A. 2C:5-1, and against the peace of this State, the government and dignity of the same.

COUNT FIVE

(Attempted Endangering the
Welfare of a child - Third Degree)

COLBY NOLAN MAULDIN

on or about January 26, 2008, at the Township of Berlin, in the County of Camden, elsewhere, and within the jurisdiction of this Court, did purposely attempt to engage in sexual conduct which would impair or debauch the morals of "Niki Sky," contrary to the provisions of N.J.S.A. 2C:5-1 and N.J.S.A. 2C:24-4a, and against the peace of this State, the government and dignity of the same.

COUNT SIX

(Obscenity for Persons under 18, Attempt - Third Degree)

COLBY NOLAN MAULDIN



COUNT SEVEN

(Luring or Enticing a Child by Electronic Means, Attempt -
Second Degree)

COLBY NOLAN MAULDIN

on or about January 26, 2008, at the Township of Berlin, in the
County of Camden, elsewhere, and within the jurisdiction of this
Court, did attempt via electronic means, to lure or entice a
child, or one he reasonably believes to be a child, to meet or
appear at any other place with the purpose to commit a criminal
offense with or against the child, or one he reasonably believes
to be a child, contrary to the provisions of N.J.S.A. 2C:13-6,
and N.J.S.A. 2C:5-1, and against the peace of this State, the
government and dignity of the same.
