The Grand Jurors of and for the State of New Jersey, upon their
s, present that:

COUNT ONE

(Conspiracy - Second Degree)

ALTERIQ BRYANT and LAQUAN EPPS

on or about January 8, 2008, in the City of Newark, County of Essex, and within the jurisdiction of this Court, with the purpose of promoting or facilitating the commission of the crimes of Robbery, Possession of a Controlled Dangerous Substance and Possession of a Controlled Dangerous Substance With Intent to Distribute, did agree

that:

A. One or more of them knowingly would engage in conduct which would constitute the aforesaid crimes, or

B. One of them knowingly would aid in the planning, solicitation or commission of said crimes, that is:

1. In the course of committing a theft, knowingly did put Herbert Womack and Claudia Cascardo in fear of immediate bodily injury while armed with a deadly weapon, contrary to the provisions of N.J.S.A. 2C:15-1;

2. Purposely or knowingly did possess a Controlled Dangerous Substance, that is, cocaine, contrary to the provisions of N.J.S.A. 2C:35-10a(1);

3. Purposely or knowingly did possess or have under their control with intent to distribute, a Controlled Dangerous Substance, that is, cocaine, contrary to the provisions of N.J.S.A. 2C:35-5a(1)

all in violation of N.J.S.A. 2C:5-2, and against the peace of this State, the government and dignity of the same.

COUNT TWO

(Robbery - First Degree)

ALTERIQ BRYANT and LAQUAN EPPS

on or about January 8, 2008, in the City of Newark, County of Essex, and within the jurisdiction of this Court, in the course of committing a theft, knowingly did put Herbert Womack in fear of immediate bodily injury while armed with a deadly weapon, contrary to the provisions of N.J.S.A. 2C:15-1, and against the peace of this State, the government and dignity of the same.

COUNT THREE

(Robbery - First Degree)

ALTERIQ BRYANT and LAQUAN EPPS

on or about January 8, 2008, in the City of Newark, County of Essex, and within the jurisdiction of this Court, in the course of committing a theft, knowingly did put Claudia Cascardo in fear of immediate bodily injury while armed with a deadly weapon, contrary to the provisions of N.J.S.A. 2C:15-1, and against the peace of this State, the government and dignity of the same.

COUNT FOUR

(Unlawful Possession of a Weapon - Third Degree)

ALTERIQ BRYANT and LAQUAN EPPS

on or about January 8, 2008, in the City of Newark, County of Essex, and within the jurisdiction of this Court, knowingly did possess a handgun, either actually or constructively, that is, a .40 caliber Smith & Wesson semiautomatic pistol (Serial No. VCC9002), without having first obtained a permit to carry same, contrary to the provisions of N.J.S.A. 2C:39-5b, and against the peace of this State, the government and dignity of the same.

COUNT FIVE

(Unlawful Possession of a Weapon - Second Degree)

ALTERIQ BRYANT and LAQUAN EPPS

on or about January 8, 2008, in the City of Newark, County of Essex, and within the jurisdiction of this Court, knowingly did possess a firearm, either actually or constructively, that is a .40 caliber Smith & Wesson semiautomatic pistol (Serial No. VCC9002), with a purpose to use it unlawfully against the person or property of another, contrary to the provisions of N.J.S.A. 2C:39-4a, and against the peace of this State, the government and dignity of the same.

COUNT SIX

(Eluding Officer - Second Degree)

ALTERIQ BRYANT

on or about January 8, 2008, in the City of Newark, County of Essex, elsewhere, and within the jurisdiction of this Court, while operating a vehicle, did knowingly flee or attempt to elude a law enforcement officer after having received a signal from such officer to bring his vehicle to a full stop, and in so doing, created a risk of death or injury to a law enforcement officer and others, contrary to the provisions of N.J.S.A. 2C:29-2b, and against the peace of this State, the government and dignity of the same.

COUNT SEVEN

(Aggravated Assault - Second Degree)

ALTERIQ BRYANT

on or about January 8, 2008, in the City of Newark, County of Essex, and within the jurisdiction of this Court, did cause bodily injury to New Jersey State Police Trooper Michael Leonardi while fleeing or attempting to elude a law enforcement officer in violation of N.J.S.A. 2C:29-2b, contrary to the provisions of N.J.S.A. 2C:12-1b(6), and against the peace of this State, the government and dignity of the same.

COUNT EIGHT

(Aggravated Assault - Second Degree)

ALTERIQ BRYANT

on or about January 8, 2008, in the Township of Bloomfield, County of Essex, and within the jurisdiction of this Court, did cause bodily injury to Michael Archibald while fleeing or attempting to elude a law enforcement officer in violation of N.J.S.A. 2C:29-2b, contrary to the provisions of N.J.S.A. 2C:12-1b(6), and against the peace of this State, the government and dignity of the same.

COUNT NINE

(Possession of a Controlled Dangerous Substance - Third Degree)

ALTERIQ BRYANT and LAQUAN EPPS

on or about January 8, 2008, in the City of Newark, County of Essex, elsewhere, and within the jurisdiction of this Court, purposely or knowingly did possess a controlled dangerous substance, that is, cocaine, either actually or constructively, contrary to the provisions of N.J.S.A. 2C:35-10a(1), and against the peace of this State, the government and dignity of the same.

COUNT TEN

(Possession of a Controlled Dangerous Substance With Intent to
Distribute - Third Degree)

ALTERIQ BRYANT and LAQUAN EPPS

on or about January 8, 2008, in the City of Newark, County of Essex,
elsewhere, and within the jurisdiction of this Court, purposely or
knowingly did possess or have under their control with intent to
distribute a controlled dangerous substance, that is, cocaine,
contrary to the provisions of N.J.S.A. 2C:35-5a(1), and against the
peace of this State, the government and dignity of the same.

COUNT ELEVEN

(Obstructing Administration of Law or Other Governmental Function -
Fourth Degree)

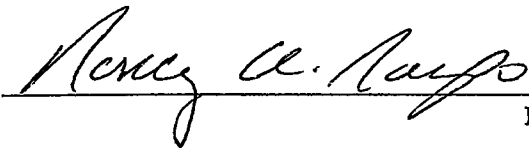
LAQUAN EPPS

obstruct, impair or prevent the administration of law or other
governmental function thereby obstructing the investigation or

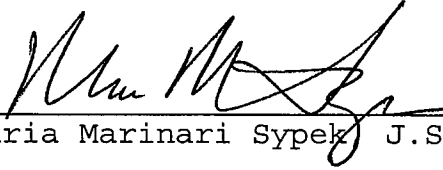

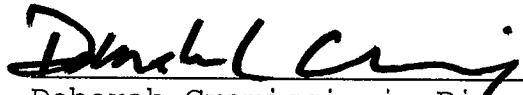

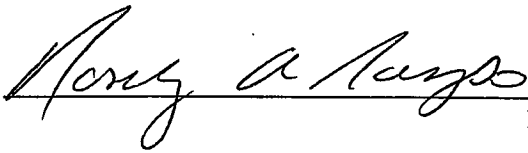

the same.



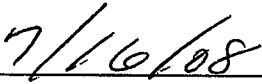
