David Charles Murray, having been charged upon oath with one count of unlawful possession of a weapon, contrary to N.J.S.A.

2C:39-5b, one count of possession of prohibited weapons and devices, contrary to N.J.S.A. 2C:39-3b, one count of unlawful possession of a weapon, contrary to N.J.S.A. 2C:39-5c, one count of unlawful defacement of a weapon, contrary to N.J.S.A. 2C:39-9e, and one count of possession of prohibited weapons and devices, contrary to N.J.S.A. 2C:39-3f, and having requested to be tried upon Accusation by the Court, and the request having been granted: Erin Callahan, Deputy Attorney General, for the State of New Jersey alleges that:

#### COUNT ONE

(Unlawful Possession of a Weapon - Second Degree)

DAVID CHARLES MURRAY

between on or about August 20, 2008, and October 16, 2008, at the Borough of Chatham, in the County of Morris, at the Town of Kearny, in the County of Hudson, elsewhere and within the

jurisdiction of this Court, knowingly did possess a weapon, that is, a Kel Tec, .32 caliber handgun, bearing restored serial number C4P55, a High Point by Bee Miller, .45 caliber handgun, bearing restored serial number X4104023, a Sturm, Ruger & Company, Inc. .45 caliber handgun, bearing an obliterated serial number, a Kel Tec P-32 .223 caliber semi-automatic pistol, bearing restored serial number P4715, and a Kel Tec PF-9 9mm Luger, bearing an obliterated serial number, without having first obtained firearms purchaser identification cards, as provided in N.J.S.A. 2C:58-3, contrary to the provisions of N.J.S.A. 2C:39-5b, and against the peace of this State, the government and dignity of same.

### COUNT TWO

(Possession of Prohibited Weapons and Devices - Third Degree)

DAVID CHARLES MURRAY

between on or about August 20, 2008, and October 16, 2008, at the Borough of Chatham, in the County of Morris, elsewhere and within the jurisdiction of this Court, did knowingly have in his possession sawed-off shotguns, that is, a Mossberg 12-gauge slide action shotgun, bearing an obliterated serial number, and a Maverick by Mossberg 12-gauge slide action shotgun, bearing an obliterated serial number, contrary to N.J.S.A. 20:39-3b, and against the peace of this State, the government and dignity of the same.

#### COUNT THREE

(Unlawful Possession of a Weapon - Third Degree)

DAVID CHARLES MURRAY

between on or about August 20, 2008, and October 16, 2008, at the Borough of Chatham, in the County of Morris, elsewhere and within the jurisdiction of this Court, knowingly did possess a weapon, that is, Romarm SA/CUGIR WASR-10 semi-automatic rifle, bearing restored serial number 1-68895, and a Romarm SA/CUGIR WASR-10 semi-automatic rifle, bearing restored serial number 1-49604 without having first obtained permits to carry same as provided in N.J.S.A. 2C:58-4, contrary to the provisions of N.J.S.A. 2C:39-5c, and against the peace of this State, the government and dignity of same.

## COUNT FOUR

(Unlawful Defacement of a Weapon - Third Degree)

DAVID CHARLES MURRAY

between on or about August 20, 2008, and October 16, 2008, at the Borough of Chatham, in the County of Morris, at the Town of Kearny, in the County of Hudson, elsewhere and within the jurisdiction of this Court, did knowingly deface firearms, that is, a Kel Tec, .32 caliber handgun, bearing restored serial number C4P55, a High Point by Bee Miller .45 caliber handgun, bearing restored serial number X4104023, a Mossberg 12-gauge slide action shotgun, bearing an obliterated serial number, a Sturm, Ruger & Company, Inc. .45 caliber handgun, bearing an obliterated serial number, a Romarm SA/CUGIR WASR-10 semiautomatic rifle, bearing restored serial number 1-68895, a Maverick by Mossberg 12-gauge slide action shotgun, bearing an obliterated serial number, a Kel Tec P-32 .223 caliber semiautomatic pistol, bearing restored serial number P4715, a Kel Tec PF-9 9mm Luger, bearing an obliterated serial number, and a Romarm SA/CUGIR WASR-10 semi-automatic rifle, bearing restored serial number 1-49604, contrary to the provisions of N.J.S.A. 2C:39-9e, and against the peace of this State, the government and dignity of same.

# COUNT FIVE

(Possession of Prohibited Weapons and Devices - Fourth Degree)

DAVID CHARLES MURRAY

between on or about August 20, 2008, and October 16, 2008, at the Borough of Chatham, in the County of Morris, elsewhere and within the jurisdiction of this Court, did knowingly have in his possession any hollow nose or dum-dum bullet, or who knowingly has in his possession any body armor breaching or penetrating ammunition that is, .45 caliber hollow point bullets, contrary to the provisions of N.J.S.A. 2C:39-3f, and against the peace of this State, the government, and dignity of the same.
