## COUNT ONE

(Unlawful Discharge of a Pollutant - Third Degree)

RD SECAUCUS, LLC

## ROSDEV HOSPITALITY SECAUCUS, LP

between on or about January 1, 2008 and on or about June 8, 2009 at the Town of Secaucus, in the County of Hudson, elsewhere, and within the jurisdiction of this Court, purposely, knowingly or recklessly did violate the "Water Pollution Control Act," by unlawfully discharging a pollutant without a valid New Jersey

Pollution Discharge Elimination System permit issued by the Commissioner of the Department of Environmental Protection or a valid National Pollution Discharge Elimination System permit issued by the Administrator of the United States Environmental Protection

Agency, in that the said RD SECAUCUS, LLC, doing business as CROWNE PLAZA HOTEL SECAUCUS, doing business as ROSDEV HOSPITALITY SECAUCUS, LP, on approximately a weekly basis, purposely, knowingly or recklessly did release, spill, leak, pump, pour, emit, empty or dump pollutants, namely water contaminated with sewage, solid waste, chemicals, specifically chlorine, or other residues, from an outside pit onto lands next to the Hackensack River, from which said pollutants might flow or drain into said River, without a valid New Jersey or National Pollution Discharge Elimination System permit, at or near 2 Harmon Plaza, Secaucus, contrary to provisions of N.J.S.A. 58:10A-10f(2), N.J.S.A. 58:10A-6a, and N.J.S.A. 2C:2-7, and against the peace of this State, the government and dignity of the same.
