COUNT ONE

(Endangering the Welfare of a Child)

(Distribution of Child Pornography - Second Degree)

ANGELO CROCCO

between on or about November 12, 2008 and November 18, 2008, at the Township of Belville, in the County of Essex, elsewhere, and within the jurisdiction of this Court, did knowingly sell, give, provide, lend, trade, mail, deliver, transfer, publish, distribute, circulate, disseminate, present, exhibit, advertise, offer or agree to offer, through any means, including the Internet, a photograph, film, videotape, computer program(s) or file(s), or any other reproduction or reconstruction, which depicts a child engaging in a prohibited sexual act or in the simulation of such an act as defined by N.J.S.A. 2C:24-4b(1), that is, the said ANGELO CROCCO, did distribute email containing attachments depicting nude children for the purpose of sexual stimulation or gratification of the viewer, contrary to the provisions of N.J.S.A. 2C:24-4b(5)(a), and

against the peace of this State, the government and dignity of the same.

COUNT TWO

(Endangering the Welfare of a Child)

(Distribution of Child Pornography - Second Degree)

ANGELO CROCCO

on or about February 25, 2009, at the Township of Belville, in the County of Essex, elsewhere, and within the jurisdiction of this Court, did knowingly sell, give, provide, lend, trade, mail, deliver, transfer, publish, distribute, circulate, disseminate, present, exhibit, advertise, offer or agree to offer, through any means, including the Internet, a photograph, film, videotape, computer program(s) or file(s), or any other reproduction or reconstruction, which depicts a child engaging in a prohibited sexual act or in the simulation of such an act as defined by N.J.S.A. 2C:24-4b(1), that is, the said ANGELO CROCCO, did distribute email containing attachments depicting nude children for the purpose of sexual stimulation or gratification of the viewer, contrary to the provisions of N.J.S.A. 2C:24-4b(5) (a), and against the peace of this State, the government and dignity of the same.

COUNT THREE


(Endangering the Welfare of a Child)

(Possession of Child Pornography - Fourth Degree)

ANGELO CROCCO

between on or about November 12, 2008 and on or about March 23, 2009, at the Township of Belleville, in the County of Essex, elsewhere, and within the jurisdiction of this Court, did knowingly possess or knowingly view any photograph(s), computer program(s) or file(s) depicting children engaged in prohibited sexual acts or in the simulation of such acts as defined by N.J.S.A. 2C:24-4b(1), including on the Internet, and also contained on computer media, contrary to the provisions of N.J.S.A. 2C:24-4b(5)(b), and against the peace of this State, the government and dignity of the same.


