INDICTMENT

BARRINGTON WILLIAMS

The Grand Jurors of and for the State of New Jersey, upon their oaths, present that:

COUNT ONE

(Official Misconduct - Second Degree)

BARRINGTON WILLIAMS

on or about July 10, 2008, at the City of Irvington, in the County of Essex, elsewhere, and within the jurisdiction of this Court, BARRINGTON WILLIAMS, being a public servant, that is, a sworn law enforcement officer for New Jersey Transit, having thereby the official functions and duties among others to display good faith, honesty and integrity, to be impervious to corrupting influences and to refrain from soliciting or accepting from any person anything of value for the performance of or for refraining from the performance of his duties or for violation thereof, and acting with a purpose to obtain a benefit for himself, did commit acts relating to his office constituting unauthorized acts and did refrain from performing a duty which is imposed upon him or clearly inherent in the nature of his office, that is, the said

crimes, contrary to the provisions of $\underline{\text{N.J.S.A.}}$ 2C:30-2b, and against the peace of this State, the government and dignity of the same.

COUNT TWO

(Possession of a Weapon During Commission of Certain Crimes - Second Degree)

BARRINGTON WILLIAMS

on or about July 10, 2008, at the City of Irvington, in the County of Essex, elsewhere, and within the jurisdiction of this Court, knowingly did possess a firearm, namely a Sig Sauer Handgun, while in the course of committing or attempting to commit a violation of N.J.S.A. 2C:35-5, contrary to the provisions of N.J.S.A. 2C:39-4.1(a), and against the peace of this State, the government and dignity of the same.

COUNT THREE

(Possession with Intent to Distribute a Controlled Dangerous Substance - Third Degree)

BARRINGTON WILLIAMS

on or about July 10, 2008, at the City of Irvington, in the County of Essex, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did posses with intent to distribute a controlled dangerous substance, that is, marijuana, in a quantity of one ounce or more but less than five pounds including any adulterants or dilutants, contrary to the provisions of N.J.S.A. 2C:35-5a(1) and N.J.S.A. 2C:35-5b(11), and against the peace of this State, the government and dignity of the same.

COUNT FOUR

(Possession of a Controlled Dangerous Substance - Fourth Degree)

BARRINGTON WILLIAMS

on or about July 10, 2008, at the City of Irvington, in the County of Essex, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did possess a controlled dangerous substance, that is, marijuana, in a quantity of more than 50 grams including any adulterants or dilutants, contrary to the provisions of N.J.S.A. 2C:35-10(a)(3), and against the peace of this State, the government and dignity of the same.
