The Grand Jurors of and for the State of New Jersey, upon their oaths, present that:

COUNT ONE

(Official Misconduct - Second Degree)

JEFFREY CARD

on or about February 16, 2005, at the Township of Hamilton, in the County of Mercer and at the Borough of Sussex, in the County Sussex, elsewhere and within the jurisdiction of this Court, did commit the offense of official misconduct, in that the said JEFFREY CARD, acting with the purpose to obtain a benefit for himself or another or to injure or to deprive another of a benefit, did commit an act relating to his office, but constituting an unauthorized exercise of his official functions, knowing that such act was unauthorized or that he was committing it in an unauthorized manner, or did refrain from performing a duty imposed upon him by law or clearly inherent in the nature of his office; that is, the said JEFFREY CARD, then and there

being a public servant, to wit: a Borough of Sussex employee, having thereby the official functions and duties, among others, to utilize public property entrusted to him by virtue of his office for the public good, to refrain from using public property for private purposes, to perform his duties in a legal and proper manner, to display good faith, honesty and integrity, and to be impervious to corrupting influences, did utilize public property entrusted to him by the Borough of Sussex, to wit: the premises of the Borough of Sussex and one or more computers located therein, to attempt to purposely or knowingly commit an act of sexual contact upon "nj kris14boi" when "nj_kris14boi" was at least 13 years old, but less than 16 years old and JEFFREY CARD was at least 4 years older than "nj_kris14boi", contrary to the provisions of N.J.S.A. 2C:5-1, N.J.S.A. 2C:14-3b, and N.J.S.A. 2C:14-2c(4), with the purpose to secure a benefit to himself or another, contrary to the provisions of N.J.S.A. 2C:30-2, and against the peace of this State, the government and dignity of same.

COUNT TWO

(Attempted Endangering the Welfare of a Child - Third Degree)

JEFFREY CARD

on or about February 16, 2005, at the Township of Hamilton, in the County of Mercer and at the Borough of Sussex, in the County Sussex, elsewhere and within the jurisdiction of this Court, did attempt to engage in sexual conduct which would impair or debauch the morals of a child, namely "nj_krisl4boi", contrary to the provisions of N.J.S.A. 2C:5-1, and N.J.S.A. 2C:24-4(a), and against the peace of this State, the government and dignity of the same.

COUNT THREE

(Attempted Criminal Sexual Contact - Fourth Degree)

JEFFREY CARD

on or about February 16, 2005, at the Township of Hamilton, in the County of Mercer and at the Borough of Sussex, in the County Sussex, elsewhere and within the jurisdiction of this Court, did attempt to purposely or knowingly commit an act of sexual contact upon "nj_kris14boi" when "nj_kris14boi" was at least 13 years old, but less than 16 years old and JEFFREY CARD was at least 4 years older than "nj_kris14boi", contrary to the provisions of N.J.S.A. 2C:5-1, 2C:14-3b, and N.J.S.A. 2C:14-2c(4), and against the peace of this State, the government and dignity of the same.

COUNT FOUR

(Official Misconduct - Second Degree)

JEFFREY CARD

on or about March 28, 2005, at the Township of Hamilton, in the County of Mercer and at the Borough of Sussex, in the County Sussex, elsewhere and within the jurisdiction of this Court, did commit the offense of official misconduct, in that the said JEFFREY CARD, acting with the purpose to obtain a benefit for himself or another or to injure or to deprive another of a benefit, did commit an act relating to his office, but constituting an unauthorized exercise of his official functions, knowing that such act was unauthorized or that he was committing it in an unauthorized manner, or did refrain from performing a duty imposed upon him by law or clearly inherent in the nature of his office; that is, the said JEFFREY CARD, then and there being a public servant, to wit: a Borough of Sussex employee, having thereby the official functions and duties, among others, to utilize public property entrusted to him by virtue of his office for the public good, to refrain from using public property for private purposes, to perform his duties in a legal and proper manner, to display good faith, honesty and integrity, and to be impervious to corrupting influences, did utilize public property entrusted to him by the Borough of Sussex, to wit: the premises of the Borough of Sussex and one or more

computers located therein, to attempt to purposely or knowingly commit an act of sexual contact upon "nj_kris14boi" when "nj_kris14boi" was at least 13 years old, but less than 16 years old and JEFFREY CARD was at least 4 years older than "nj_kris14boi", contrary to the provisions of N.J.S.A. 2C:5-1, N.J.S.A. 2C:14-3b, and N.J.S.A. 2C:14-2c(4), and/or to attempt to purposely or knowingly commit an act of sexual penetration upon "nj_kris14boi" when "nj_kris14boi" was at least 13 years old, but less than 16 years old and JEFFREY CARD was at least 4 years older than "nj_kris14boi", contrary to the provisions of N.J.S.A. 2C:5-1, and N.J.S.A. 2C:14-2c(4), with the purpose to secure a benefit to himself or another, contrary to the provisions of N.J.S.A. 2C:30-2, and against the peace of this State, the government and dignity of same.

COUNT FIVE

(Attempted Sexual Assault - Second Degree)

JEFFREY CARD

on or about March 28, 2005, at the Township of Hamilton, in the County of Mercer and at the Borough of Sussex, in the County Sussex, elsewhere and within the jurisdiction of this Court, did attempt to purposely or knowingly commit an act of sexual penetration upon "nj_kris14boi" when "nj_kris14boi" was at least 13 years old, but less than 16 years old and JEFFREY CARD was at least 4 years older than "nj_kris14boi", contrary to the provisions of N.J.S.A. 2C:5-1, and N.J.S.A. 2C:14-2c(4), and against the peace of this State, the government and dignity of the same.

COUNT SIX

(Attempted Endangering the Welfare of a Child - Third Degree)

JEFFREY CARD

on or about March 28, 2005, at the Township of Hamilton, in the County of Mercer and at the Borough of Sussex, in the County Sussex, elsewhere and within the jurisdiction of this Court, did attempt to engage in sexual conduct which would impair or debauch the morals of a child, namely "nj_kris14boi", contrary to the provisions of N.J.S.A. 2C:5-1, and N.J.S.A. 2C:24-4(a), and against the peace of this State, the government and dignity of the same.

COUNT SEVEN

(Attempted Criminal Sexual Contact - Fourth Degree)

JEFFREY CARD

on or about March 28, 2005, at the Township of Hamilton, in the County of Mercer and at the Borough of Sussex, in the County Sussex, elsewhere and within the jurisdiction of this Court, did attempt to purposely or knowingly commit an act of sexual contact upon "nj_kris14boi" when "nj_kris14boi" was at least 13 years old, but less than 16 years old and Jeffrey Card was at least 4 years older than "nj_kris14boi", contrary to the provisions of N.J.S.A. 2C:5-1, N.J.S.A. 2C:14-3b, and N.J.S.A. 2C:14-2c(4), and against the peace of this State, the government and dignity of the same.

COUNT EIGHT

(Official Misconduct - Second Degree)

JEFFREY CARD

on or about April 2, 2005, at the Township of Hamilton, in the County of Mercer and at the Borough of Sussex, in the County Sussex, elsewhere and within the jurisdiction of this Court, did commit the offense of official misconduct, in that the said JEFFREY CARD, acting with the purpose to obtain a benefit for himself or another or to injure or to deprive another of a benefit, did commit an act relating to his office, but constituting an unauthorized exercise of his official functions, knowing that such act was unauthorized or that he was committing it in an unauthorized manner, or did refrain from performing a duty imposed upon him by law or clearly inherent in the nature of his office; that is, the said JEFFREY CARD, then and there being a public servant, to wit: a Borough of Sussex employee, having thereby the official functions and duties, among others, to utilize public property entrusted to him by virtue of his office for the public good, to refrain from using public property for private purposes, to perform his duties in a legal and proper manner, to display good faith, honesty and integrity, and to be impervious to corrupting influences, did utilize public property entrusted to him by the Borough of Sussex, to

wit: the premises of the Borough of Sussex and one or more computers located therein, to attempt to purposely or knowingly commit an act of sexual contact upon "nj_kris14boi" when "nj_kris14boi" was at least 13 years old, but less than 16 years old and JEFFREY CARD was at least 4 years older than "nj_kris14boi", contrary to the provisions of N.J.S.A. 2C:5-1, N.J.S.A. 2C:14-3b, and N.J.S.A. 2C:14-2c(4), with the purpose to secure a benefit to himself or another, contrary to the provisions of N.J.S.A. 2C:30-2, and against the peace of this State, the government and dignity of same.

COUNT NINE

(Attempted Endangering the Welfare of a Child - Third Degree)

JEFFREY CARD

on or about April 2, 2005, at the Township of Hamilton, in the County of Mercer and at the Borough of Sussex, in the County Sussex, elsewhere and within the jurisdiction of this Court, did attempt to engage in sexual conduct which would impair or debauch the morals of a child, namely "nj_krisl4boi", contrary to the provisions of N.J.S.A. 2C:5-1, and N.J.S.A. 2C:24-4(a), and against the peace of this State, the government and dignity of the same.

COUNT TEN

(Attempted Criminal Sexual Contact - Fourth Degree)

JEFFREY CARD

on or about April 2, 2005, at the Township of Hamilton, in the County of Mercer and at the Borough of Sussex, in the County Sussex, elsewhere and within the jurisdiction of this Court, did attempt to purposely or knowingly commit an act of sexual contact upon "nj_krisl4boi" when "nj_krisl4boi" was at least 13 years old, but less than 16 years old and JEFFREY CARD was at least 4 years older than "nj_krisl4boi", contrary to the provisions of N.J.S.A. 2C:5-1, N.J.S.A. 2C:14-3b, and N.J.S.A. 2C:14-2c(4), and against the peace of this State, the government and dignity of the same.

COUNT ELEVEN

(Attempted Endangering the Welfare of a Child - Third Degree)

JEFFREY CARD

on or about April 10, 2005, at the Township of Hamilton, in the County of Mercer and at the Borough of Sussex, in the County Sussex, elsewhere and within the jurisdiction of this Court, did attempt to engage in sexual conduct which would impair or debauch the morals of a child, namely "nj_kris14boi", contrary to the provisions of N.J.S.A. 2C:5-1, and N.J.S.A. 2C:24-4(a), and against the peace of this State, the government and dignity of the same.

COUNT TWELVE

(Attempted Criminal Sexual Contact - Fourth Degree)

JEFFREY CARD

on or about April 10, 2005, at the Township of Hamilton, in the County of Mercer and at the Borough of Sussex, in the County Sussex, elsewhere and within the jurisdiction of this Court, did attempt to purposely or knowingly commit an act of sexual contact upon "nj_kris14boi" when "nj_kris14boi" was at least 13 years old, but less than 16 years old and JEFFREY CARD was at least 4 years older than "nj_kris14boi", contrary to the provisions of N.J.S.A. 2C:5-1, N.J.S.A. 2C:14-3b, and N.J.S.A. 2C:14-2c(4), and against the peace of this State, the government and dignity of the same.

COUNT THIRTEEN

(Attempted Endangering the Welfare of a Child - Third Degree)

JEFFREY CARD

on or about April 16, 2005, at the Township of Hamilton, in the County of Mercer and at the Borough of Sussex, in the County Sussex, elsewhere and within the jurisdiction of this Court, did attempt to engage in sexual conduct which would impair or debauch the morals of a child, namely "nj_kris14boi", contrary to the provisions of N.J.S.A. 2C:5-1, and N.J.S.A. 2C:24-4(a), and against the peace of this State, the government and dignity of the same.

COUNT FOURTEEN

(Attempted Criminal Sexual Contact - Fourth Degree)

JEFFREY CARD

on or about April 16, 2005, at the Township of Hamilton, in the County of Mercer and at the Borough of Sussex, in the County Sussex, elsewhere and within the jurisdiction of this Court, did attempt to purposely or knowingly commit an act of sexual contact upon "nj_kris14boi" when "nj_kris14boi" was at least 13 years old, but less than 16 years old and JEFFREY CARD was at least 4 years older than "nj_kris14boi", contrary to the provisions of N.J.S.A. 2C:5-1, N.J.S.A. 2C:14-3b, and N.J.S.A. 2C:14-2c(4), and against the peace of this State, the government and dignity of the same.

COUNT FIFTEEN

(Endangering the Welfare of a Child)

(Possession of Child Pornography - Fourth Degree)

JEFFREY CARD

on or about April 27, 2005, at the Borough of Sussex, in the County of Sussex, and within the jurisdiction of this Court, elsewhere and within the jurisdiction of this Court, did knowingly possess or knowingly view any photograph(s), computer program(s) or file(s)depicting children engaged in prohibited sexual acts or in the simulation of such acts as defined by N.J.S.A. 2C:24-4b(1), including on the Internet, contrary to the provisions of N.J.S.A. 2C:24-4b(5)(b), and against the peace of this State, the government and dignity of the same.
