The Grand Jurors of and for the State of New Jersey, upon their oaths, present that:

# COUNT ONE

(Unlawful Possession of An Assault Firearm - Second Degree)

#### HORACE DIXON

on or about July 17, 2009, at the City of Glassboro, in the County of Gloucester, elsewhere, and within the jurisdiction of this Court, knowingly did have in his possession an assault firearm, that is, a FEG semiautomatic rifle, Serial Number EF 5317H, with a detachable magazine, without having first obtained a license pursuant to N.J.S.A. 2C:58-5, registered the weapon pursuant to N.J.S.A. 2C:58-12, or rendered the weapon inoperable pursuant to N.J.S.A. 2C:58-13, contrary to the provisions of N.J.S.A. 2C:39-5f, and against the peace of this State, the government and dignity of the same.

## COUNT TWO

(Unlawful Possession of a Rifle - Third Degree)
HORACE DIXON

on or about July 17, 2009, at the City of Glassboro, in the County of Gloucester, elsewhere, and within the jurisdiction of this Court, knowingly did possess a rifle, that is, a FEG semiautomatic rifle, Serial Number EF 5317H, without having first obtained a firearms purchaser identification card in accordance with the provisions of N.J.S.A. 2C:58-3, contrary to the provisions of N.J.S.A. 2C:39-5c(1), and against the peace of this State, the government and dignity of the same.

#### COUNT THREE

(Unlawful Disposition of an Assault Firearm - Third Degree)

#### HORACE DIXON

on or about July 17, 2009, at the City of Glassboro, in the County of Gloucester, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did transport, ship, sell, or otherwise dispose of an assault firearm, that is, a FEG semiautomatic rifle, Serial Number EF 5317H, without being registered or licensed to do so pursuant to N.J.S.A. 2C:58-1 et seq., contrary to the provisions of N.J.S.A. 2C:39-9g, and against the peace of this State, the government and dignity of the same.

# COUNT FOUR

(Possession of a Prohibited Weapon - Fourth Degree)
HORACE DIXON

on or about July 17, 2009, at the City of Glassboro, in the County of Gloucester, elsewhere, and within the jurisdiction of this Court, knowingly did possess a large capacity ammunition magazine for a FEG semi-automatic rifle, contrary to the provisions of N.J.S.A. 2C:39-3j, and against the peace of this State, the government and dignity of the same.

## COUNT FIVE

# (Unlawful Possession of an Assault Firearm - Second Degree)

## HORACE DIXON

on or about July 17, 2009, at the City of Glassboro, in the County of Gloucester, elsewhere, and within the jurisdiction of this Court, knowingly did have in his possession an assault firearm, that is, a .223 caliber Norinco semi-automatic rifle, Serial Number 84S 314886, with a detachable magazine, without having first obtained a license pursuant to N.J.S.A. 2C:58-5, registered the weapon pursuant to N.J.S.A. 2C:58-12, or rendered the weapon inoperable pursuant to N.J.S.A. 2C:58-13, contrary to the provisions of N.J.S.A. 2C:39-5f, and against the peace of this State, the government and dignity of the same.

## COUNT SIX

(Unlawful Possession of a Rifle - Third Degree)
HORACE DIXON

on or about July 17, 2009, at the City of Glassboro, in the County of Gloucester, elsewhere, and within the jurisdiction of this Court, knowingly did possess a rifle, that is, a .223 caliber Norinco semiautomatic rifle, Serial Number 84S 314886, without having first obtained a firearms purchaser identification card in accordance with the provisions of N.J.S.A. 2C:58-3, contrary to the provisions of N.J.S.A. 2C:39-5c(1), and against the peace of this State, the government and dignity of the same.

### COUNT SEVEN

(Unlawful Disposition of an Assault Firearm - Third Degree)

## HORACE DIXON

on or about July 17, 2009, at the City of Glassboro, in the County of Gloucester, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did transport, ship, sell, or otherwise dispose of an assault firearm, that is, a .223 caliber Norinco semiautomatic rifle, Serial Number 84S 314886, without being registered or licensed to do so pursuant to N.J.S.A. 2C:58-1 et seq., contrary to the provisions of N.J.S.A. 2C:39-9g, and against the peace of this State, the government and dignity of the same.

# COUNT EIGHT

(Possession of a Prohibited Weapon - Fourth Degree)
HORACE DIXON

on or about July 17, 2009, at the City of Glassboro, in the County of Gloucester, elsewhere, and within the jurisdiction of this Court, knowingly did possess a large capacity ammunition magazine for a .223 caliber Norinco semi-automatic rifle, contrary to the provisions of N.J.S.A. 2C:39-3j, and against the peace of this State, the government and dignity of the same.

# COUNT NINE

(Possession of a Prohibited Weapon - Fourth Degree)
HORACE DIXON

on or about July 17, 2009, at the City of Glassboro, in the County of Gloucester, elsewhere, and within the jurisdiction of this Court, knowingly did possess a large capacity ammunition magazine for a .223 caliber Norinco semi-automatic rifle, contrary to the provisions of N.J.S.A. 2C:39-3j, and against the peace of this State, the government and dignity of the same.

# COUNT TEN

(Possession of a Prohibited Weapon - Fourth Degree)

HORACE DIXON

on or about July 17, 2009, at the City of Glassboro, in the County of Gloucester, elsewhere, and within the jurisdiction of this Court, knowingly did possess a large capacity ammunition magazine for a .223 caliber Norinco semi-automatic rifle, contrary to the provisions of N.J.S.A. 2C:39-3j, and against the peace of this State, the government and dignity of the same.

## COUNT ELEVEN

(Unlawful Possession of a Handgun - Second Degree)

HORACE DIXON

on or about August 7, 2009, at the City of Glassboro, in the County of Gloucester, elsewhere, and within the jurisdiction of this Court, knowingly did possess a handgun, that is, a .380 caliber Bersa semi-automatic pistol, Serial Number 756722, without having first obtained a permit to carry the same as provided in N.J.S.A. 2C:58-4, contrary to the provisions of N.J.S.A. 2C:39-5b, and against the peace of this State, the government and dignity of the same.

# COUNT TWELVE

(Unlawful Disposition of a Firearm - Fourth Degree)
HORACE DIXON

on or about August 7, 2009, at the City of Glassboro, in the County of Gloucester, elsewhere, and within the jurisdiction of this Court, knowingly did transport, ship, sell, or otherwise dispose of a firearm, that is, a .380 auto caliber Bersa semi-automatic pistol, Serial Number 756722, without being licensed or registered to do so as provided in N.J.S.A. 2C:58-1 et seq., contrary to the provisions of N.J.S.A. 2C:39-9d, and against the peace of this State, the government and dignity of the same.

# COUNT THIRTEEN

(Unlawful Possession of a Rifle - Third Degree)
HORACE DIXON

on or about August 7, 2009, at the City of Glassboro, in the County of Gloucester, elsewhere, and within the jurisdiction of this Court, knowingly did possess a rifle, that is, a .223 caliber Romarm semi-automatic rifle, Serial Number S3 00386 1999, without having first obtained a firearms purchaser identification card in accordance with the provisions if N.J.S.A. 2C:58-3, contrary to the provisions of N.J.S.A. 2C:39-5c(1), and against the peace of this State, the government and dignity of the same.

# COUNT FOURTEEN

(Unlawful Disposition of a Firearm - Fourth Degree)

HORACE DIXON

on or about August 7, 2009, at the City of Glassboro, in the County of Gloucester, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did transport, ship, sell, or otherwise dispose of a firearm, that is, a .223 caliber Romarm semi-automatic rifle, Serial Number S3 00386 1999, without being registered or licensed to do so pursuant to N.J.S.A. 2C:58-1 et seq., contrary to the provisions of N.J.S.A. 2C:39-9d, and against the peace of this State, the government and dignity of the same.

# COUNT FIFTEEN

(Possession of a Prohibited Weapon - Fourth Degree)

HORACE DIXON

on or about August 7, 2009, at the City of Glassboro, in the County of Gloucester, elsewhere, and within the jurisdiction of this Court, knowingly did possess a large capacity ammunition magazine for a .223 caliber Romarm semi-automatic rifle, contrary to the provisions of N.J.S.A. 2C:39-3j, and against the peace of this State, the government and dignity of the same.

## COUNT SIXTEEN

(Possession of a Prohibited Weapon - Fourth Degree)
HORACE DIXON

on or about August 7, 2009, at the City of Glassboro, in the County of Gloucester, elsewhere, and within the jurisdiction of this Court, knowingly did possess a large capacity ammunition magazine for a .223 caliber Romarm semi-automatic rifle, contrary to the provisions of N.J.S.A. 2C:39-3j, and against the peace of this State, the government and dignity of the same.

# COUNT SEVENTEEN

(Unlawful Possession of a Handgun - Second Degree)

HORACE DIXON

on or about August 13, 2009, at the City of Glassboro, in the County of Gloucester, elsewhere, and within the jurisdiction of this Court, knowingly did possess a handgun, that is, a .45 caliber Sig Sauer semi-automatic pistol, Serial Number G249697, without having first obtained a permit to carry the same as provided in N.J.S.A. 2C:58-4, contrary to the provisions of N.J.S.A. 2C:39-5b, and against the peace of this State, the government and dignity of the same.

# COUNT EIGHTEEN

(Unlawful Possession of a Handgun - Second Degree)

HORACE DIXON

on or about August 13, 2009, at the City of Glassboro, in the County of Gloucester, elsewhere, and within the jurisdiction of this Court, knowingly did possess a handgun, that is, a .380 caliber Star semi-automatic pistol, Serial Number 1593532, without having first obtained a permit to carry the same as provided in N.J.S.A. 2C:58-4, contrary to the provisions of N.J.S.A. 2C:39-5b, and against the peace of this State, the government and dignity of the same.

# COUNT NINETEEN

(Unlawful Possession of a Shotgun - Third Degree)
HORACE DIXON

on or about August 13, 2009, at the City of Glassboro, in the County of Gloucester, elsewhere, and within the jurisdiction of this Court, knowingly did possess a shotgun, that is, a 12 gauge Shandong 1st Machine Works pump action shotgun, Serial Number 0401139, without having first obtained a firearms purchaser identification card in accordance with the provisions if N.J.S.A. 2C:58-3, contrary to the provisions of N.J.S.A. 2C:39-5c(1), and against the peace of this State, the government and dignity of the same.

### COUNT TWENTY

(Unlawful Possession of an Assault Firearm - Second Degree)

#### HORACE DIXON

on or about August 13, 2009, at the City of Glassboro, in the County of Gloucester, elsewhere, and within the jurisdiction of this Court, knowingly did have in his possession an assault firearm, that is, a 7.62 X 39 mm Romarm semi-automatic rifle, Serial Number AO-2813-82, with a detachable magazine, without having first obtained a license pursuant to N.J.S.A. 2C:58-5, registered the weapon pursuant to N.J.S.A. 2C:58-12, or rendered the weapon inoperable pursuant to N.J.S.A. 2C:58-13, contrary to the provisions of N.J.S.A. 2C:39-5f, and against the peace of this State, the government and dignity of the same.

## COUNT TWENTY-ONE

(Unlawful Possession of a Rifle - Third Degree)
HORACE DIXON

on or about August 13, 2009, at the City of Glassboro, in the County of Gloucester, elsewhere, and within the jurisdiction of this Court, knowingly did possess a rifle, that is, a 7.62 x 39 mm Romarm semi-automatic rifle, Serial Number AO-2813-82, without having first obtained a firearms purchaser identification card in accordance with the provisions of N.J.S.A. 2C:58-3, contrary to the provisions of N.J.S.A. 2C:39-5c(1), and against the peace of this State, the government and dignity of the same.

# COUNT TWENTY-TWO

(Possession of a Prohibited Weapon - Fourth Degree)
HORACE DIXON

on or about August 13, 2009, at the City of Glassboro, in the County of Gloucester, elsewhere, and within the jurisdiction of this Court, knowingly did possess a large capacity ammunition magazine for a  $7.62 \times 39$  mm Romarm semi-automatic rifle, contrary to the provisions of N.J.S.A. 2C:39-3j, and against the peace of this State, the government and dignity of the same.

# COUNT TWENTY-THREE

(Unlawful Possession of an Assault Firearm - Second Degree)

#### HORACE DIXON

on or about August 13, 2009, at the City of Glassboro, in the County of Gloucester, elsewhere, and within the jurisdiction of this Court, knowingly did have in his possession an assault firearm, that is, .223 Ruger semi-automatic rifle, Serial Number 195-82363, with a detachable magazine, without having first obtained a license pursuant to N.J.S.A. 2C:58-5, registered the weapon pursuant to N.J.S.A. 2C:58-12, or rendered the weapon inoperable pursuant to N.J.S.A. 2C:58-13, contrary to the provisions of N.J.S.A. 2C:39-5f, and against the peace of this State, the government and dignity of the same.

## COUNT TWENTY-FOUR

(Unlawful Possession of an Assault Firearm - Second Degree)

## HORACE DIXON

on or about August 13, 2009, at the City of Glassboro, in the County of Gloucester, elsewhere, and within the jurisdiction of this Court, knowingly did possess an assault rifle, that is, a 7.62 X 39 mm Norinco semi-automatic rifle, Serial Number A000064, with a detachable magazine, without having first obtained a license pursuant to N.J.S.A. 2C:58-5, registered the weapon pursuant to N.J.S.A. 2C:58-12, or rendered the weapon inoperable pursuant to N.J.S.A. 2C:58-13, contrary to the provisions of N.J.S.A. 2C:39-5f, and against the peace of this State, the government and dignity of the same.

# COUNT TWENTY-FIVE

(Unlawful Possession of a Machine Gun - Second Degree)

HORACE DIXON

on or about August 13, 2009, at the City of Glassboro, in the County of Gloucester, elsewhere, and within the jurisdiction of this Court, knowingly did possess a machine gun, that is, an 8 mm Deutsche Waffen Munitionsfabriken (DWM), water-cooled, belt-fed machine gun, Serial Number 38148, without being licensed to do so as provided in N.J.S.A. 2C:58-5, contrary to the provisions of N.J.S.A. 2C:39-5a, and against the peace of this State, the government and dignity of the same.
