The Grand Jurors of the State of new Jersey, upon their
oaths, present that:

COUNT ONE

(Conspiracy - Second Degree)

NICHOLAS C. STENS

ROBERTO L. ORTIZ

JOSEPH P. HACKNEY

DOMINICK M. LEONETTI JR.

ROBERT A. SCHAFER

and

EUGENE "RICK" WILSON

who are named as the defendants herein, and other persons whose

identities are both known and unknown to the Grand Jurors, who are named as co-conspirators but not as defendants herein, between on or about January 10, 2011, and on or about April 7, 2011, at the Borough of Collingswood, and at the Townships of Haddon, Gloucester and Voorhees, all in the County of Camden, at the Township of Maple Shade, in the County of Burlington, and at the Borough of National Park, in the County of Gloucester, elsewhere, and within the jurisdiction of this Court, with the purpose of promoting or facilitating the commission of the crime of distribution of a controlled dangerous substance, that is, cocaine, did agree together and with a member of the Voorhees Police Department working in an undercover capacity, that:

A. One or more of them knowingly would engage in conduct which would constitute the aforesaid crime; or

B. One or more of them knowingly would aid in the planning, solicitation, or commission of the said crime, that is:

1. Knowingly or purposely to distribute a controlled dangerous substance, that is, cocaine, in a quantity of five ounces or more including any adulterants or dilutants, contrary to the provisions of N.J.S.A. 2C:35-5a(1), N.J.S.A. 2C:35-5b(1), and N.J.S.A. 2C:35-5c.

All in violation of N.J.S.A. 2C:5-2, and against the peace of this State, the government and dignity of the same.

COUNT TWO

(Unlawful Possession of a Handgun - Second Degree)

NICHOLAS C. STENS

on or about January 10, 2011, at the Township of Voorhees, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly did possess a certain weapon, that is, a Smith & Wesson Sig Arms, Inc., semi-automatic .40 caliber handgun, Model P229, serial number AG25463, without having first obtained a permit to carry same as provided N.J.S.A. 2C:58-4, contrary to the provisions of N.J.S.A. 2C:39-5b, and against the peace of this State, the government and dignity of the same.

COUNT THREE

(Unlawful Disposition of a Firearm - Fourth Degree)

NICHOLAS C. STENS

on or about January 10, 2011, at the Township of Voorhees, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly did sell or otherwise dispose of a firearm, that is, a Smith & Wesson Sig Arms, Inc., semi-automatic .40 caliber handgun, Model P229, serial number AG25463, without being licensed or registered to do so as provided in N.J.S.A. 2C:58-1 et seq., contrary to the provisions of N.J.S.A. 2C:39-9d, and against the peace of this State, the government and dignity of the same.

COUNT FOUR

(Distribution of a Controlled Dangerous Substance - First Degree)

NICHOLAS C. STENS

on or about February 4, 2011, at the Township of Voorhees, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did distribute a controlled dangerous substance, that is, cocaine, in a quantity of five ounces or more including any adulterants or dilutants, contrary to the provisions of N.J.S.A. 2C:35-5a(1) and N.J.S.A. 2C:35-5b(1), and against the peace of this State, the government and dignity of the same.

COUNT FIVE

(Distribution of a Controlled Dangerous Substance within 500 Feet
of Certain Public Property - Second Degree)

NICHOLAS C. STENS

on or about February 4, 2011, at the Township of Voorhees, in the
County of Camden, and within the jurisdiction of this Court,
knowingly or purposely did distribute a controlled dangerous
substance, that is, cocaine, in violation of N.J.S.A. 2C:35-5a,
while within 500 feet of certain public property, that is, the
Miarotta Field, contrary to the provisions of N.J.S.A. 2C:35-7.1,
and against the peace of this State, the government and dignity
of the same.

COUNT SIX

(Unlawful Possession of a Shotgun - Third Degree)

NICHOLAS C. STENS

on or about February 18, 2011, at the Township of Voorhees, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly did possess a firearm, that is, a Mossberg 500A 12-gauge shotgun, serial number R723030, without having first obtained a firearms purchaser identification card in accordance with the provisions of N.J.S.A. 2C:58-3, contrary to the provisions of N.J.S.A. 2C:39-5c(1), and against the peace of this State, the government and dignity of the same.

COUNT SEVEN

(Unlawful Disposition of a Firearm - Fourth Degree)

NICHOLAS C. STENS

on or about February 18, 2011, at the Township of Voorhees, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly did sell or otherwise dispose of a firearm, that is, a Mossberg 500A 12-gauge shotgun, serial number R723030, without being licensed or registered to do so as provided in N.J.S.A. 2C:58-1 et seq., contrary to the provisions of N.J.S.A. 2C:39-9d, and against the peace of this State, the government and dignity of the same.

COUNT EIGHT

(Distribution of a Controlled Dangerous Substance - First Degree)

NICHOLAS C. STENS

on or about March 4, 2011, at the Township of Voorhees, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did distribute a controlled dangerous substance, that is, cocaine, in a quantity of five ounces or more including any adulterants or dilutants, contrary to the provisions of N.J.S.A. 2C:35-5a(1) and N.J.S.A. 2C:35-5b(1), and against the peace of this State, the government and dignity of the same.

COUNT NINE

(Distribution of a Controlled Dangerous Substance within 500 Feet
of Certain Public Property - Second Degree)

NICHOLAS C. STENS

on or about March 4, 2011, at the Township of Voorhees, in the
County of Camden, elsewhere, and within the jurisdiction of this
Court, knowingly or purposely did distribute a controlled
dangerous substance, that is, cocaine, in violation of N.J.S.A.
2C:35-5a, while within 500 feet of certain public property, that
is, the Miarotta Field, contrary to the provisions of N.J.S.A.
2C:35-7.1, and against the peace of this State, the government
and dignity of the same.

COUNT TEN

(Possession with Intent to Distribute a Controlled
Dangerous Substance - First Degree)

NICHOLAS C. STENS


on or about April 7, 2011, at the Borough of Collingswood, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did possess with intent to distribute a controlled dangerous substance, that is, cocaine, in a quantity of five ounces or more including any adulterants or dilutants, contrary to the provisions of N.J.S.A. 2C:35-5a(1) and N.J.S.A. 2C:35-5b(1) and against the peace of this State, the government and dignity of the same.

COUNT ELEVEN

(Possession of Controlled Dangerous Substance - Third Degree)


JOSEPH HACKNEY

on or about April 8, 2011, at the Borough of Haddonfield, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did possess a controlled dangerous substance, that is, cocaine, a Schedule II controlled dangerous substance, contrary to the provisions of N.J.S.A. 2C:35-10a(1), and against the peace of this State, the government and dignity of the same.


