COUNT ONE

between on or about April 3, 2006, and on or about June 13, 2007 at the Township of Marlboro, in the County of Monmouth, elsewhere, and within the jurisdiction of this Court, with the purpose of promoting or facilitating the crime of theft by deception, did agree that:

- A. One or more of them knowingly would engage in conduct which would constitute the aforesaid crime, or
- B. One or more of them would aid in the planning, solicitation or commission of said crime, that is:
- 1. Theft by Deception, in that they would purposely obtain the property of others by deception, in an amount of \$75,000 or more, contrary to the provisions of N.J.S.A. 2C:20-4.

BELLOTTI, JONATHAN P. DOMASH, DIVERSIFIED ASSETS, INC., ELLIOT N. BAUER, MORTGAGE LOAN SOLUTIONS and MICHAEL R. FIGLER did obtain certain personal identifying information pertaining to L.P., namely, her name, address, social security number, and date of birth, and did use this information in order to assume the identity of and represent themselves as L.P., without authorization, and with the purpose to obtain a \$340,000 mortgage from Gateway Funding Diversified Mortgage Services, LP, contrary to the provisions of

N.J.S.A. 2C:21-17a(4), N.J.S.A. 2C:2-6, and N.J.S.A. 2C:2-7, and against the peace of this State, the government and dignity of the same.

provisions of <u>N.J.S.A.</u> 2C:21-1(3), <u>N.J.S.A.</u> 2C:2-6, and <u>N.J.S.A.</u> 2C:2-7, and against the peace of this State, the government and dignity of the same.
