- 2. With the purpose of promoting or facilitating the commission of the crime of racketeering, did conspire or agree together and with persons whose identities are known and unknown to the Grand Jurors, that:
  - A. One or more of them would engage in conduct which would

constitute the crime of racketeering; or

B. One or more of them would aid in the planning, solicitation or commission of the crime of racketeering, that is, to conduct or participate, directly or indirectly, in the conduct of the enterprise's affairs through a pattern of racketeering activity, including the commission of crimes of the first degree, in violation of N.J.S.A. 2C:41-2d, all as hereinafter described.

# THE RELEVANT TIMES AND PLACES

# THE PURPOSES OF THE ENTERPRISE

#### THE PATTERN OF RACKETEERING ACTIVITY
