The Grand Jurors of and for the State of New Jersey, upon their

oaths, present that:

COUNT ONE

(Criminal Mischief - Third Degree)

ABDULLAH S. BRYANT

and other persons whose identities are unknown to the Grand Jurors, between on or about January 1, 2016, and on or about April 17, 2017, at the City of Newark, in the County of Essex, elsewhere, and within the jurisdiction of this Court, purposely or knowingly did damage tangible property of another, thereby causing pecuniary loss of \$2,000 or more, that is ABDULLAH S. BRYANT, and other persons whose identities are unknown to the Grand Jurors, purposely or knowingly did damage property owned or operated by the New Jersey Department of Transportation, located under the elevated Route 78

and Route 22 overpass between Frelinghuysen Avenue and the AMTRAK/New Jersey Transit Northeast Corridor Rail Line, Newark, by dumping debris onto said property, and causing damage of \$2,000 or more, contrary to the provisions of N.J.S.A. 2C:17-3a(1), and against the peace of this State, the government and dignity of the same.

COUNT TWO

(Criminal Mischief - Third Degree)

ABDULLAH S. BRYANT

and other persons whose identities are unknown to the Grand Jurors, between on or about January 1, 2016, and on or about April 17, 2017, at the City of Newark, in the County of Essex, elsewhere, and within the jurisdiction of this Court, purposely or knowingly did damage tangible property of another, thereby causing pecuniary loss of \$2,000 or more, that is ABDULLAH S. BRYANT, and other persons whose identities are unknown to the Grand Jurors, purposely or knowingly did damage property owned or operated jointly by AMTRAK and the New Jersey Department of Transportation, located under the Route 21 overpass, near Poinier Street, Newark, by dumping debris onto said property, and causing damage of \$2,000 or more, contrary to the provisions of N.J.S.A. 2C:17-3a(1), and against the peace of this State, the government and dignity of the same.

COUNT THREE

(Vandalizing Railroad Crossing Devices, Property - Third Degree)

ABDULLAH S. BRYANT

and other persons whose identities are unknown to the Grand Jurors, between on or about January 1, 2016, and on or about April 17, 2017, at the City of Newark, in the County of Essex, elsewhere, and within the jurisdiction of this Court, purposely or knowingly or recklessly did deface, damage, or obstruct railroad property or equipment, thereby causing pecuniary loss of \$2,000 or more, that is ABDULLAH S. BRYANT, and other persons whose identities are unknown to the Grand Jurors, purposely or knowingly or recklessly did deface, damage, or obstruct railroad property or equipment owned or operated jointly by AMTRAK and the New Jersey Department of Transportation, located under the Route 21 overpass, near Poinier Street, Newark, by dumping debris onto said property, and causing damage of \$2,000 or more, contrary to the provisions of N.J.S.A. 2C:33-14.1, and against the peace of this State, the government and dignity of the same.

COUNT FOUR

(Illegal Collection of Solid Waste - Third Degree) ABDULLAH S. BRYANT

and other persons whose identities are unknown to the Grand Jurors, between on or about January 1, 2016, and on or about April 17, 2017, at the Cities of East Orange, Irvington, and Newark, and at the Townships of Maplewood, South Orange, and West Orange, all in the County of Essex, at the Town of Harrison, in the County of Hudson, at the Township of Montville, in the County of Morris, and elsewhere and within the jurisdiction of this Court, knowingly or recklessly did engage in the collection of 100 cubic yards or more of solid waste, whether for profit or otherwise, in violation of the requirements of section 5 of P.L.1970, c.39 (C.13:1E-5), in that ABDULLAH S. BRYANT, and other persons whose identities are unknown to the Grand Jurors, who at no point during the relevant time period had approval from the New Jersey Department of Environmental Protection to collect solid waste, did in knowingly or recklessly engage in the collection of 100 cubic yards or more of solid waste, contrary to the provisions of N.J.S.A. 13:1E-9.6d, and against the peace of this State, the government and dignity of the same.

COUNT FIVE

(Illegal Transportation of Solid Waste - Third Degree) ABDULLAH S. BRYANT

and other persons whose identities are unknown to the Grand Jurors, between on or about January 1, 2016, and on or about April 17, 2017, at the City of Newark, in the County of Essex, recklessly did transport greater than 100 cubic yards of solid waste or cause or permit to be transported greater than 100 cubic yards of solid waste within this State, whether for profit or otherwise, to a disposal site which does not have approval from the New Jersey Department of Environmental Protection to accept solid waste for disposal, in that ABDULLAH S. BRYANT, and other persons whose identities are unknown to the Grand Jurors, recklessly did transport greater than 100 cubic yards of solid waste solid waste or cause or permit to be transported greater than 100 cubic yards of solid waste within this State, specifically debris consisting of various refuse, at property owned or operated by the New Jersey Department of Transportation, located under the elevated Route 78 overpass between Frelinghuysen Avenue Route 22 AMTRAK/New Jersey Transit Northeast Corridor Rail Line, Newark, a site not authorized by the New Jersey Department of Environmental Protection as a disposal site, contrary to the provisions of

 $\underline{\text{N.J.S.A.}}$ 13:1E-9.6b(2), and against the peace of this State, the government and dignity of the same.

COUNT SIX

(Illegal Disposal of Solid Waste - Third Degree) ABDULLAH S. BRYANT

and other persons whose identities are unknown to the Grand Jurors, between on or about January 1, 2016, and on or about April 17, 2017, at the City of Newark, in the County of Essex, elsewhere, and within the jurisdiction of this Court, recklessly did dispose of solid waste or cause or permit the disposal of solid waste, or otherwise engage in the disposal of solid waste within this State, in an amount greater than 100 cubic yards of solid waste, at a place which does not have approval from the New Jersey Department of Environmental Protection to accept solid waste for disposal, in that the ABDULLAH S. BRYANT, and other persons whose identities are unknown to the Grand Jurors, recklessly did dispose of or permit or cause the disposal of greater than 100 cubic yards of solid waste, specifically debris consisting of various refuse, at property owned or operated by the New Jersey Department of Transportation, located the elevated Route 78 and Route 22 overpass between Frelinghuysen Avenue and the AMTRAK/New Jersey Transit Northeast Corridor Rail Line, Newark, a site not authorized by the New Jersey Department of Environmental Protection as a disposal site, contrary to the provisions of N.J.S.A. 13:1E-9.6b(1), and against the peace

of this State, the government and dignity of the same.
