Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed <u>and</u> (2) the defendant is the one who committed it:

On April 11, 2019, an individual with a profile name "Mike" contacted an undercover detective posing as a 14 year old female named "Taylor" on the mobile application Skout. The individual identified himself as a 22 year old male looking for rough sex. The "child" Taylor stated that she was 14 years old, to which "Mike" stated "you are too young for chat." The conversation then moved to text message where "Mike" went on to say he was looking for sex, and asked the child to send photos. "Mike" asked if he could "lick your all body tonight and do you like suck between my legs" going on to specify that he was referring to his "dick." The target went on to ask if he could meet up with the child, and made arrangements to meet at a predetermined location in Bergen County. At approximately 8:15 p.m. the target, later identified as Dariush Ghamarnezhad arrived at the location and was taken into custody.
