1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On April 11, 2019, an individual with a profile name "morrisnoel" contacted an undercover detective posing as a 14-year-old male child named "Mark" on the mobile application Adam4Adam. The individual identified himself as a 29-year-old male. The "child" stated that he was 14 years old, to which "morrisnoel" stated "oh ok." The individual asked if the child wanted to meet up, and then went on to say that he would like to "rim [the child], give [the child] oral and sex and kissing." The individual then asked the child if he could "host" or "car sex." The individual made arrangements to meet at a predetermined location in Bergen County. At approximately 10:10 p.m., the target, later identified as Larry Noel, arrived at the location and was taken into custody.
