The woman was arrested and prosecuted by the Camden County Prosecutors Office. She pled guilty to Permitting a child to engage in pornography and was sentenced to 7 years state prison. Her cellphone was searched, and the referenced emails were contained therein. Subpoena and CDW results showed the emails were sent and received by Reitz.
