"Kevdakidd93" further told the child, "I'd definitely wanna suck ur cock." The individual asked the child to send naked pictures and offered to come to the child's home tomorrow to perform oral sex on the child. The individual further stated that he wanted to do "Sex stuff. Kinky stuff. Embarrassing stuff. Chores. Anything." with the child. The individual made arrangements to meet the child at a predetermined location in Bergen County. At approximately 5:45 p.m., the target, later identified as Kevin Roth, arrived at the location and was taken into custody.
