The Grand Jurors of and for the State of New Jersey, upon their oaths, present that:

COUNT ONE

(Murder - First Degree)

TERRELL SAVAGE

on or about May 18, 2018, at the City of Millville, in the County of Cumberland, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did cause the death of Victim #1, and/or did cause serious bodily injury resulting in the death of Victim #1, contrary to the provisions of N.J.S.A. 2C:11-3a(1) and/or N.J.S.A. 2C:11-3a(2), and against the peace of this State, the government and dignity of the same.

COUNT TWO

(Attempted Murder - First Degree)

TERRELL SAVAGE

on or about May 18, 2018, at the City of Millville, in the County of Cumberland, elsewhere, and within the jurisdiction of this Court, purposely did attempt to cause the death of Victim #2, contrary to the provisions of N.J.S.A. 2C:11-3a(1), N.J.S.A. 2C:5-1, and against the peace of this State, the government and dignity of the same.

COUNT THREE

(Attempted Murder - First Degree)

TERRELL SAVAGE

on or about May 18, 2018, at the City of Millville, in the County of Cumberland, elsewhere, and within the jurisdiction of this Court, purposely did attempt to cause the death of Victim #3, contrary to the provisions of N.J.S.A. 2C:11-3a(1), N.J.S.A. 2C:5-1, and against the peace of this State, the government and dignity of the same.

COUNT FOUR

(Unlawful Possession of a Weapon - Second Degree) TERRELL SAVAGE

on or about May 18, 2018, at the City of Millville, in the County of Cumberland, elsewhere, and within the jurisdiction of this Court, knowingly did possess a certain weapon, that is, a Browning 9mm luger caliber semiautomatic pistol, serial number 245NW62342, without having first obtained a permit to carry same as provided in N.J.S.A. 2C:58-4, contrary to the provisions of N.J.S.A. 2C:39-5b, and against the peace of this State, the government and dignity of the same.

COUNT FIVE

(Possession of a Weapon for an Unlawful Purpose - Second Degree)

TERRELLE SAVAGE

on or about May 18, 2018, at the City of Millville, in the County of Cumberland, elsewhere, and within the jurisdiction of this Court, did possess a certain weapon, that is, a Browning 9mm luger caliber semiautomatic pistol, serial number 245NW62342, with the purpose to use it unlawfully against the person or property of another, contrary to the provisions of N.J.S.A. 2C:39-4a, and against the peace of this State, the government and dignity of the same.

COUNT SIX

(Tampering with Physical Evidence - Fourth Degree) TERRELL SAVAGE

between on or about May 18, 2018, and on or about May 22, 2018, at the City of Millville, in the County of Cumberland, elsewhere and within the jurisdiction of this Court, believing that an official investigation was pending or about to be instituted, knowingly did alter, destroy, conceal, or remove any article, object, record, document, or other thing of physical substance, that is, a Browning 9mm luger caliber semiautomatic pistol, serial number 245NW62342, with the purpose to impair its verity or availability in such proceeding or investigation, contrary to N.J.S.A. 2C:28-6a(1), and against the peace of this State, the government and dignity of the same.

COUNT SEVEN

(Hindering Apprehension or Prosecution of Self - Third Degree)

TERRELL SAVAGE

between on or about May 18, 2018, and on or about May 22, 2018, at the City of Millville, in the County of Cumberland, at the City of Newark, in the County of Essex, at the City of Atlantic City, in the County of Atlantic, elsewhere and within the jurisdiction of this Court, with the purpose to hinder his own apprehension, prosecution, conviction, or punishment did suppress, by way of concealment or destruction, any evidence of the crime or tamper with a document or other source of information, regardless of its admissibility in evidence, which might aid in his discovery or apprehension or in the lodging of a charge against him; or gave false information to a law enforcement officer, contrary to the provisions of N.J.S.A. 2C:29-3b(1), N.J.S.A. 2C:29-3b(4), and against the peace of this State, government and dignity of the same.

COUNT EIGHT

(Unlawful Possession of a Weapon - First Degree)

TERRELL SAVAGE

on or about May 18, 2018, at the City of Millville, in the County of Cumberland, elsewhere, and within the jurisdiction of this Court, having been previously convicted of the crime of Fourth Degree Aggravated Assault With a Firearm in Cumberland County on accusation number CUM100400209A, knowingly did possess a certain weapon, that is, a Browning 9mm luger caliber semiautomatic pistol, serial number 245NW62342, without having first obtained a permit to carry same as provided in N.J.S.A. 2C:58-4, contrary to the provisions of N.J.S.A. 2C:39-5b, N.J.S.A. 2C:39-5j, and against the peace of this State, the government and dignity of the same.

COUNT NINE

(Certain Persons Not to Have Weapons - Second Degree)

TERRELL SAVAGE

on or about May 18, 2018, at the City of Millville, in the County of Cumberland, elsewhere, and within the jurisdiction of this Court, having been convicted of the crime of Fourth Degree Aggravated Assault With a Firearm in Cumberland County, on accusation number CUM100400209A, did purchase, own, possess or control the following firearm: a Browning Arms Company 9mm handgun, serial number 245NW62342, contrary to the provisions of N.J.S.A. 2C:39-7b, and against the peace of this State, the government and dignity of the same.

The Grand Jurors of and for the State of New Jersey, upon their oaths, present that TERRELL SAVAGE on or about May 18, 2018, at the City of Millville, in the County of Cumberland, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did cause the death of Victim #1 by his own conduct, and/or did cause serious bodily injury resulting in the death of Victim #1 by his own conduct, as alleged in Count One of the Indictment and that the following aggravating factors are present regarding Count One of the Indictment:

1. TERRELL SAVAGE knowingly or purposely created a grave risk of death to Victim #2 and Victim #3 during the commission of the murder of Victim #1, contrary to N.J.S.A. 2C:11-3b(4)(B), and

against the peace of this State, the government and dignity of the same.
