Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On April 12, 2019, an adult male with the username "Tapped you 21" made contact on the social media application "Grindr" with an undercover detective posing as a 14 year old male child. The adult immediately sent a photograph of his bare buttocks and penis. The male then goes on to say that he is 25 years old. The "child" tells him that he is 14. The user then asked the child for a picture. The next day, on April 13, 2019, the user again contacts the "child" asking for pictures and eventually asks "u want dick" followed by another picture of an adult penis. The user then states "let me fuck you first" upon finding out that the "child" is a virgin. He goes on to ask "u wanna fuck" and makes arrangements to meet with the child at a predetermined location. The user then states "[u] sure u wanna getting fuck because uber is 20 dallors to u" as he does not drive. Later that evening at approximately 9 p.m. the user, later identified as Teodoro Alvarez-Ortega, traveled on foot to the predetermined location in Bergen County and was arrested at the scene."
