The Grand Jurors of and for the State of New Jersey, upon their oaths, present that:

COUNT ONE

(Racketeering - First Degree) WILBERT SEGARRA LUIS I. ROSADO MELIGZA CRUZ MARIA MORALES RAMON SALDANA RAFAEL VELAZQUEZ MIGDOEL MORALES-CRUZ MICHAEL CANALES ANGEL MARTINEZ DANIEL SANJURJO EMANUEL MORALES

and

JOSEPH COOPER, JR.

and other persons whose identities are known and unknown to the Grand Jurors, who are named as a co-conspirators and members of the enterprise, but not as defendants herein, at the times and places herein specified, did commit the crime of Racketeering, that is, the defendants and other persons employed by or associated with an enterprise engaged in or the activities of which affected trade or commerce, purposely or knowingly did conduct or participate directly or indirectly, or did conspire in the conduct of the enterprise's affairs through a pattern of racketeering activity, including the commission of a crime of violence and/or a crime of the first degree and/or the use of firearms, in violation of <u>N.J.S.A.</u> 2C:41-2c and <u>N.J.S.A.</u> 2C:41-2d, all as hereinafter described.

THE RELEVANT TIMES AND PLACES

The predicate criminal activity occurred between on or about January 29, 2019, and on or about October 4, 2019, at the City of Camden, in the County of Camden, in the State of New Jersey, elsewhere, and within the jurisdiction of this Court.

THE ENTERPRISE

WILBERT SEGARRA, LUIS I. ROSADO, MELIGZA CRUZ, MARIA MORALES, RAMON SALDANA, RAFAEL VELAZQUEZ, MIGDOEL MORALES-CRUZ, MICHAEL CANALES, ANGEL MARTINEZ, DANIEL SANJURJO, EMANUEL MORALES, JOSEPH COOPER, JR., and other persons whose identities are known and unknown to the Grand Jurors, who are named as a co-conspirators and members of the enterprise, but not as defendants herein, did constitute an enterprise within the meaning of <u>N.J.S.A.</u> 2C:41-1c, that is, a group of individuals associated in fact, for the purposes set forth below.

THE PURPOSES OF THE ENTERPRISE

It was a part of the conspiracy that the purposes of the enterprise would include the following:

A. Obtaining money and property for members and associates of the enterprise through violations of the laws of the

State of New Jersey, including the commission of the crimes of attempted murder; aggravated assault; possession of a weapon for an unlawful purpose; leader of a narcotics trafficking network; possession with intent to distribute and distribution of controlled dangerous substances;

- B. Accomplishing the goals of the enterprise through the collection of proceeds generated through the commission of various crimes from members of the enterprise, said proceeds to be utilized for the advancement and benefit of the enterprise or its leaders.
- C. To conceal from law enforcement authorities the existence of the enterprise, the means and locations from which it conducts its affairs, including but not limited to using wireless telephones, a variety of locations, residences or motor vehicles for storage or delivery of controlled dangerous substances, which members and associates of the enterprise bought and sold.

THE PATTERN OF RACKETEERING ACTIVITY

The pattern of racketeering activity, as defined in <u>N.J.S.A.</u> 2C:41-1d, consisted of at least two incidents of racketeering conduct by the enterprise during the relevant time, including Attempted Murder (N.J.S.A. 2C:11-3); Aggravated Assault (N.J.S.A. 2C:12-1);

Possession of a Weapon for an Unlawful Purpose (N.J.S.A. 2C:39-4); Leader of a Narcotics Trafficking Network, (N.J.S.A. 2C:35-3); Possession with Intent to Distribute and Distribution of a Controlled Dangerous Substance (N.J.S.A. 35-5); Distribution of a Controlled Dangerous Substance within 1,000 feet of School Property (N.J.S.A. 2C:35-7); and Conspiracy to commit these crimes, as described herein and in Counts Three, Four, Six, Seven, Nineteen, Twenty, Twenty-One, Twenty-Two, Twenty-Three, Twenty-Four, Twenty-Five, Twenty-Six, Twenty-Seven, Twenty-Eight, Twenty-Nine, Thirty, Thirty-One, Thirty-Two, Thirty-Three, Thirty-Four, Thirty-Five, Thirty-Six, Thirty-Seven, Thirty-Eight, Thirty-Nine, Forty, Forty-One, Forty-Two, Forty-Three, Forty-Four, Forty-Five, Porty-Six, Forty-Seven, Forty-Eight, and Forty-Nine of this Indictment.

WILBERT SEGARRA

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy; Attempted Murder; Aggravated Assault; Possession of a Weapon for an Unlawful Purpose; and Leader of a Narcotics Trafficking Network; which racketeering conduct is the subject of Counts Two, Three, Four, Six, and Seven of this Indictment.

LUIS I. ROSADO

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy; Possession with Intent to

Distribute a Controlled Dangerous Substance; Distribution of a Controlled Dangerous Substance; and Distribution of a Controlled Dangerous Substance within 1,000 feet of School Property; which racketeering conduct is the subject of Counts Two, Forty-Three, Forty-Four, and Forty-Nine of this Indictment.

MELIGZA CRUZ

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy; Possession with Intent to Distribute a Controlled Dangerous Substance; Distribution of a Controlled Dangerous Substance; and Distribution of a Controlled Dangerous Substance within 1,000 feet of School Property; which racketeering conduct is the subject of Counts Two, Twenty-One, Twenty-Two, Thirty-Nine, Forty, Forty-One, Forty-Two, Forty-Three, Forty-Four, Forty-Five, Forty-Six, Forty-Seven, Forty-Eight, and Forty-Nine of this Indictment.

MARIA MORALES

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy; Distribution of a Controlled Dangerous Substance; and Distribution of a Controlled Dangerous Substance within 1,000 feet of School Property; which racketeering conduct is the subject of Counts Two, Thirty-One, Thirty-Two, Thirty-Three, Thirty-Four, Thirty-Five, and Thirty-Six of this Indictment.

RAMON SALDANA

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy; Distribution of a Controlled Dangerous Substance; and Distribution of a Controlled Dangerous Substance within 1,000 feet of School Property; which racketeering conduct is the subject of Counts Two, Twenty-Three, Twenty-Four, Thirty-Seven, Thirty-Eight, Forty-Three, Forty-Four, Forty-Seven, and Forty-Eight of this Indictment.

RAFAEL VELAZQUEZ

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy; Possession with Intent to Distribute a Controlled Dangerous Substance; Distribution of a Controlled Dangerous Substance; and Distribution of a Controlled Dangerous Substance within 1,000 feet of School Property; which racketeering conduct is the subject of Counts Two, Twenty-Five, Twenty-Six, Thirty-Five, Thirty-Six, Forty-One, Forty-Two, and Forty-Nine of this Indictment.

MIGDOEL MORALES-CRUZ

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy; Distribution of a Controlled Dangerous Substance; and Distribution of a Controlled Dangerous Substance within 1,000 feet of School Property; which racketeering conduct is the subject of Counts Two, Thirty-Three, Thirty-Four, Thirty-Seven, and Thirty-Eight of this Indictment.

MICHAEL CANALES

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy; Distribution of a Controlled Dangerous Substance; and Distribution of a Controlled Dangerous Substance within 1,000 feet of School Property; which racketeering conduct is the subject of Counts Two, Twenty-One, Twenty-Two, Twenty-Three, Twenty-Four, Twenty-Seven, and Twenty-Eight of this Indictment.

ANGEL MARTINEZ

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy; Distribution of a Controlled Dangerous Substance; and Distribution of a Controlled Dangerous Substance within 1,000 feet of School Property; which racketeering conduct is the subject of Counts Two, Twenty-Seven, Twenty-Eight, Twenty-Nine, and Thirty of this Indictment.

DANIEL SANJURJO

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy; Distribution of a Controlled Dangerous Substance; and Distribution of a Controlled Dangerous Substance within 1,000 feet of School Property; which racketeering conduct is the subject of Counts Two, Thirty-Nine, Forty, Forty-Five, and Forty-Six of this Indictment.

EMANUEL MORALES

did commit the racketeering conduct by engaging in or conspiring

to commit repeated acts of Conspiracy; Distribution of a Controlled Dangerous Substance; and Distribution of a Controlled Dangerous Substance within 1,000 feet of School Property; which racketeering conduct is the subject of Counts Two, Thirty-Nine, Forty, Forty-One, and Forty-Two of this Indictment.

JOSEPH COOPER, JR.

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy; Attempted Murder; Aggravated Assault; Possession of a Weapon for and Unlawful Purpose; Distribution of a Controlled Dangerous Substance; and Distribution of a Controlled Dangerous Substance within 1,000 feet of School Property; which racketeering conduct is the subject of Counts Two, Three, Four, Six, Nineteen, and Twenty of this Indictment.

All in violation of <u>N.J.S.A.</u> 2C:41-2c and <u>N.J.S.A.</u> 2C:41-2d, and against the peace of this State, the government and dignity of the same.

(Conspiracy - Second Degree) WILBERT SEGARRA LUIS I. ROSADO MELIGZA CRUZ MARIA MORALES RAMON SALDANA RAFAEL VELAZQUEZ MIGDOEL MORALES-CRUZ MICHAEL CANALES ANGEL MARTINEZ EMANUEL MORALES DANIEL SANJURJO

and

JOSEPH COOPER, JR.

who are named as defendants herein, and other persons whose identities are known and unknown to the Grand Jurors, who are named as co-conspirators but not as defendants herein, between on or about January 3, 2019, and on or about October 4, 2019, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, with the purpose of promoting or facilitating the commission of the crime of distribution of a controlled dangerous substance, did agree that:

A. One or more of them would engage in conduct which would

constitute the aforesaid crime, or

B. One or more of them would aid in the planning, solicitation or commission of the said crime, that is:

1. Knowingly or purposely distribute a controlled dangerous substance, that is, heroin, in a quantity of one-half ounce or more, including any adulterants or dilutants, contrary to the provisions of <u>N.J.S.A.</u> 2C:35-5a(1) and N.J.S.A. 2C:35-5b(2);

All in violation of N.J.S.A. 2C:5-2, and against the peace of this State, the government and dignity of the same.

COUNT THREE

(Attempted Murder - First Degree)

JOSEPH COOPER, JR.

and

WILBERT SEGARRA

on or about May 24, 2019, at the City of Camden, in the County of Camden, elsewhere and within the jurisdiction of this Court, did purposely attempt to cause the death of S.R., by using a deadly weapon, that is, a firearm, and shooting S.R., contrary to the provisions of <u>N.J.S.A.</u> 2C:11-3, <u>N.J.S.A.</u> 2C:5-1, <u>N.J.S.A.</u> 2C:2-6, and against the peace of this State, the government and dignity of the same.

COUNT FOUR

(Aggravated Assault - Second Degree)

JOSEPH COOPER, JR.

and

WILBERT SEGARRA

on or about May 24, 2019, at the City of Camden, in the County of Camden, elsewhere and within the jurisdiction of this Court, did attempt to cause serious bodily injury to S.R., or caused such injury purposely or knowingly or under circumstances manifesting extreme indifference to the value of human life recklessly caused such injury, by using a deadly weapon, that is, a firearm, and shooting S.R., contrary to the provisions of <u>N.J.S.A.</u> 2C:12-1b(1), <u>N.J.S.A.</u> 2C:2-6, and against the peace of this State, the government and dignity of the same.

COUNT FIVE

(Unlawful Possession of a Weapon - Second Degree)

JOSEPH COOPER, JR.

and

WILBERT SEGARRA

on or about May 24, 2019, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly did possess a certain weapon, that is, a handgun, without having first obtained a permit to carry same as provided in <u>N.J.S.A.</u> 2C:58-4, contrary to the provisions of <u>N.J.S.A.</u> 2C:39-5b, and against the peace of this State, the government and dignity of the same.

COUNT SIX

(Possession of a Weapon for an Unlawful Purpose - Second Degree) JOSEPH COOPER, JR.

and

WILBERT SEGARRA

on or about May 24, 2019, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly did possess a certain weapon, that is, a firearm, with purpose to use it unlawfully against the person or property of another, contrary to the provisions of <u>N.J.S.A.</u> 2C:39-4a, and against the peace of this State, the government and dignity of the same.

COUNT SEVEN

(Leader of a Narcotics Trafficking Network - First Degree) WILBERT SEGARRA

between on or about January 29, 2019, and on or about October 4, 2019, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly did conspire with others as an organizer, supervisor, financier or manager, to engage for profit in a scheme or course of conduct to unlawfully manufacture, distribute, dispense, bring into or transport in this State, heroin, a Schedule I controlled dangerous substance, contrary to the provisions of <u>N.J.S.A.</u> 2C:35-3, and against the peace of this State, the government and dignity of the same.

COUNT EIGHT

(Promoting Organized Street Crime - First Degree)

WILBERT SEGARRA

LUIS I. ROSADO

and

MELIGZA CRUZ

between on or about January 29, 2019, and on or about October 4, 2019, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly did conspire with others as an organizer, supervisor, financier or manager, to commit one or more of the crimes enumerated in N.J.S.A. 2C:33-30, Distribute with Intent to and Possession specifically, Distribution of Controlled Dangerous Substances, in violation of N.J.S.A. 2C:35-5a(1) and N.J.S.A. 2C:35-5b(2), Attempted Murder, in violation of N.J.S.A. 2C:11-3; Aggravated Assault, in violation of N.J.S.A. 2C:12-1; and/or Possession of a Weapon for an Unlawful Purpose, in violation of N.J.S.A. 2C:39-4; contrary to the provisions of N.J.S.A. 2C:33-30, and against the peace of this State, the government and dignity of the same.

(Possession of a Controlled Dangerous Substance - Third Degree)

between on or about May 1, 2019, and on or about May 2, 2019, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did possess a controlled dangerous substance, that is, heroin, a Schedule I controlled dangerous substance, contrary to the provisions of <u>N.J.S.A.</u> 2C:35-10a(1), and against the peace of this State, the government and dignity of the same.

COUNT FIFTEEN

(Possession of a Controlled Dangerous Substance - Third Degree) MARIA MORALES

between on or about May 20, 2019, and on or about August 5, 2019, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did possess a controlled dangerous substance, that is, heroin, a Schedule I controlled dangerous substance, contrary to the provisions of <u>N.J.S.A.</u> 2C:35-10a(1), and against the peace of this State, the government and dignity of the same.

COUNT SIXTEEN

(Possession of a Controlled Dangerous Substance - Third Degree)

MIGDOEL MORALES-CRUZ

between on or about May 31, 2019, and on or about August 5, 2019, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did possess a controlled dangerous substance, that is, heroin, a Schedule I controlled dangerous substance, contrary to the provisions of <u>N.J.S.A.</u> 2C:35-10a(1), and against the peace of this State, the government and dignity of the same.

COUNT SEVENTEEN

(Possession of a Controlled Dangerous Substance - Third Degree)

DANIEL SANJURJO

between on or about August 21, 2019, and on or about September 4, 2019, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did possess a controlled dangerous substance, that is, heroin, a Schedule I controlled dangerous substance, contrary to the provisions of <u>N.J.S.A.</u> 2C:35-10a(1), and against the peace of this State, the government and dignity of the same.

COUNT EIGHTEEN

(Possession of a Controlled Dangerous Substance - Third Degree)

LUIS I. ROSADO

on or about October 4, 2019, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did possess a controlled dangerous substance, that is, heroin, a Schedule I controlled dangerous substance, contrary to the provisions of <u>N.J.S.A.</u> 2C:35-10a(1), and against the peace of this State, the government and dignity of the same.

COUNT NINETEEN

(Distribution of a Controlled Dangerous Substance - Third Degree)

JOSEPH COOPER, JR.

on or about January 29, 2019, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did distribute a controlled dangerous substance, that is, heroin, contrary to the provisions of <u>N.J.S.A.</u> 2C:35-5a(1), <u>N.J.S.A.</u> 2C:35-5b(3), and against the peace of this State, the government and dignity of the same.

COUNT TWENTY

(Distribution of a Controlled Dangerous Substance Within 1,000 Feet of School Property - Third Degree)

JOSEPH COOPER, JR.

on or about January 29, 2019, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did distribute a controlled dangerous substance, that is, heroin, in violation of <u>N.J.S.A.</u> 2C:35-5a, while within 1,000 feet of Cooper's Poynt Family School, which is owned by or leased to the Camden City School District and used for school purposes, contrary to the provisions of <u>N.J.S.A.</u> 2C:35-7, and against the peace of this State, the government and dignity of the same.

COUNT TWENTY-ONE

(Distribution of a Controlled Dangerous Substance - Third Degree)

MICHAEL CANALES

and

MELIGZA CRUZ

on or about February 21, 2019, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did distribute a controlled dangerous substance, that is, heroin, contrary to the provisions of <u>N.J.S.A.</u> 2C:35-5a(1), <u>N.J.S.A.</u> 2C:35-5b(3), <u>N.J.S.A.</u> 2C:2-6, and against the peace of this State, the government and dignity of the same.

COUNT TWENTY-TWO

(Distribution of a Controlled Dangerous Substance Within 1,000 Feet of School Property - Third Degree)

MICHAEL CANALES

and

MELIGZA CRUZ

on or about February 21, 2019, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did distribute a controlled dangerous substance, that is, heroin, in violation of <u>N.J.S.A.</u> 2C:35-5a, while within 1,000 feet of Cooper's Poynt Family School, which is owned by or leased to the Camden City School District and used for school purposes, contrary to the provisions of <u>N.J.S.A.</u> 2C:35-7, <u>N.J.S.A.</u> 2C:2-6, and against the peace of this State, the government and dignity of the same.

COUNT TWENTY-THREE

(Distribution of a Controlled Dangerous Substance - Third Degree)

MICHAEL CANALES

and

RAMON SALDANA
